


INTRODUCTION

ABOUT THE DYNAMIC LEARNING MAPS ALTERNATE ASSESSMENT SYSTEM

Educators use the Dynamic Learning Maps® (DLM®) Alternate Assessment System to assess what students with the most significant cognitive disabilities know and can do in the DLM assessed subjects in Grades 3–8 and one or more grades in high school. The department of education policy in each state determines the subjects and grades that are assessed. The DLM Alternate Assessment System provides accessibility by design and is guided by the core beliefs that all students should have access to challenging, grade-level content, and that based on this challenging content, test administrators must adhere to the highest levels of integrity, both in providing instruction and in administering the assessment.

STUDENTS

As defined by the U.S. Department of Education, students with the most significant cognitive disabilities have a disability or multiple disabilities that especially affect intellectual functioning and adaptive behaviors. When adaptive behaviors are significantly affected, students are unlikely to develop the skills needed to live independently and to function safely in daily life when they reach adulthood. The DLM alternate assessment is designed for students for whom general education assessments are not appropriate, even with accessibility supports.

Students taking the DLM alternate assessment require extensive direct instruction and substantial support to achieve measurable gains. They should receive academic instruction aligned to grade-level content standards, but at a reduced depth, breadth, and level of complexity.

Check with your assessment coordinator or review your DLM state webpage for the subjects and grades assessed in your state.

THE DYNAMIC LEARNING MAPS FOUNDATIONS FOR ENGLISH LANGUAGE ARTS AND MATHEMATICS

The DLM learning maps are highly connected representations of how academic skills are acquired, as reflected in research literature. Both English language arts (ELA) and mathematics have fully developed learning maps. ELA and mathematics are assessed in Grades 3–8 and one or more grades in high school.

Nodes in the maps represent discrete knowledge, skills, and understandings in either ELA or mathematics, as well as important foundational skills. The maps go beyond traditional learning progressions by including multiple and alternate pathways through which students

may develop content knowledge. The ELA learning map includes more than 2,000 nodes. The mathematics learning map includes more than 2,300 nodes, and both subject maps include more than 150 foundational nodes associated with them. More than 10,000 connections exist between the nodes in the combined maps.

ESSENTIAL ELEMENTS

The DLM content standards for ELA, mathematics, and science are called Essential Elements and are the learning targets used for the assessments. The purpose of the Essential Elements is to build a bridge from grade-level content standards to academic expectations for students with the most significant cognitive disabilities. ELA and mathematics have several similarities and will be discussed together, while science will be discussed in its own sections.

ELA AND MATHEMATICS ESSENTIAL ELEMENTS

ELA and mathematics Essential Elements are linked to the Common Core State Standards. ELA and mathematics learning maps each have small sections of critical concepts or skills, called nodes, that are needed to learn the Essential Elements for the subject. These small sections are at different levels of complexity and are called linkage levels.

ELA AND MATHEMATICS LINKAGE LEVELS

The DLM alternate assessment provides testlets for ELA and mathematics at five linkage levels. The Target linkage level is based on nodes that align to the knowledge and skills described by the Essential Element and indicate a student's performance in relationship to the grade-level target. Then, multiple pathways on the map were carefully inspected to identify nodes that link to the Target linkage level, both preceding and extending beyond it.

The least complex linkage level is called the Initial Precursor. Testlets developed at that linkage level reflect foundational nodes in the DLM learning map, which are skills and understandings necessary for learning subsequent academic content (e.g., "focus attention"). Testlets at this level are typically intended for students who do not yet have symbolic communication. Initial Precursor testlets are administered by the test administrator, who follows the instructions within the testlet, observes the student's behavior, and then records the student's responses in the testlet in Student Portal.

Two linkage levels are between the Initial Precursor and the Target linkage levels: Distal Precursor and Proximal Precursor. Testlets at the Distal Precursor and Proximal Precursor linkage levels allow students to develop the knowledge, skills, and understandings needed to reach the Target. Testlets at these linkage levels may be either teacher-administered like

For all ELA and mathematics Essential Elements that are available for assessment, resources describing their linkage levels and nodes are provided on the [Instructional Resources](#) page on the DLM website. An Excel workbook, titled [Professional Development Modules Supporting Essential Elements](#), is also available. This workbook cross-references each Essential Element to the relevant professional development modules (Figure 1). The workbook includes one tab for ELA and one for mathematics.

with DLM staff. Testing all ELA and mathematics Essential Elements in the blueprints is required during the fall and again in the spring window. The ELA and mathematics blueprints contain Essential Elements from specific ELA and mathematics claims and conceptual areas for each grade. Test administrators are guided by the blueprint requirements in making their Essential Element selections for instruction and assessment. The requirements help test administrators address the full breadth of blueprint coverage for students during each window.

UNDERSTANDING THE COMPONENTS OF THE DLM ALTERNATE ASSESSMENT SYSTEM


Understanding the DLM alternate assessment involves understanding the relationship between the components of the system. For ELA and mathematics, these components include the DLM learning maps, claims, conceptual areas, Essential Elements, nodes, linkage levels, and mini-maps.

Each DLM learning map is a large and complex representation of how students can develop academic knowledge and skills. These maps highlight multiple potential pathways that students may follow to develop knowledge and skills. The learning maps are organized into claims, conceptual areas, Essential Elements, linkage levels, and individual skills called nodes.

DLM claims are broad statements about what students are to learn and what the assessments measure. Subareas of the claims, called conceptual areas, identify large areas of conceptually-related skills in the DLM learning map and connect the maps to the overall claims. Conceptual areas are organized around common cognitive processes (Figure 2).

The Components of the DLM Alternate Assessment System for ELA and Mathematics




Essential Elements represent grade-level targets for students with the most significant cognitive disabilities. Essential Elements are embedded in the DLM learning maps and are related to small clusters of nodes within the maps called mini-maps.

Figure 3 is an example of a Grade 6 mathematics mini-map with nodes associated with one Essential Element. The nodes are identified by their linkage levels. Linkage levels are a small section of the DLM learning map containing one or more nodes that represent critical concepts or skills needed to learn the Essential Element.

Each testlet spans a portion of the DLM learning maps that contains nodes at one linkage level. Each linkage level contains one or more nodes related to an identified Essential Element. Linkage levels precede, correspond to, or go beyond the expectation expressed in the Essential Element. Linkage levels specify a student's performance in relation to the grade-level target.

ELA and mathematics each have five linkage levels:

- 1) Initial Precursor (IP)
- 2) Distal Precursor (DP)
- 3) Proximal Precursor (PP)
- 4) Target (T)
- 5) Successor (S)

The mini-maps also include untested nodes, which are designated with a UN. These untested nodes are an important part of the pathway.

HINT: A PDF with each tested Essential Element and its associated mini-map is available for ELA and mathematics on the [Instructional Resources](#) page of each state’s DLM webpage. These mini-maps show how students gain the knowledge and skills that help them achieve the Target linkage level for the Essential Element.

SCIENCE

SCIENCE DEVELOPMENT

In 2014, development of science assessments began in two phases, following the DLM model. Phase I included a 2016 spring operational assessment based on alternate science content standards at three levels of complexity in three grade bands. Phase II, which is in progress, includes the development of a learning map for science. Several professional development modules are available, and more are in progress.

ESSENTIAL ELEMENTS FOR SCIENCE

The DLM science Essential Elements are the learning targets for the science assessments. These Essential Elements are specific statements of knowledge, skills, and understandings, including science and engineering practices, and are linked to the grade-level expectations identified in the National Research Council’s Framework for K–12 Science Education. The purpose of the Essential Elements is to build a bridge from the general education content standards in science to academic expectations in science for students with the most significant cognitive disabilities.

Science Essential Elements are divided into grade bands: elementary, middle school, and high school. The assessments for each grade band are designed to assess a specific set of science Essential Elements called the blueprint, which is available on your state’s DLM webpage.

SCIENCE: THE RELATIONSHIP BETWEEN THE BLUEPRINT, ESSENTIAL ELEMENTS, AND LINKAGE LEVELS

In the DLM science blueprints, the major assessed science subjects are called domains and are assessed across all grade bands. The domains in the DLM science blueprints are physical science, life science, and Earth and space science. Within each domain, three to four core ideas have been selected for use in instruction and assessment. Core ideas are the key organizing principles in science and are taught and learned over multiple grades at increasing levels of depth and sophistication. Each core idea is further narrowed into topics.

Essential Elements were developed from the content in the domains, core ideas, and topics.

Essential Elements specify academic learning targets. In science, each Essential Element has three linkage levels:

- Initial
- Precursor
- Target

The highest science linkage level is the Target linkage level; it is most aligned to the content of the grade-level standard. The Initial and Precursor linkage levels are less complex than the Target linkage level and provide access to the Target at a reduced depth, breadth, and level of complexity.

Testlets at the Initial linkage level are typically intended for students who do not yet have symbolic communication. For these testlets, the test administrator observes the student's behavior as directed by the Educator Directions in the testlet in Student Portal. Then, in the testlet, the test administrator records their observations of the student or the student's responses.

Testlets at the Precursor linkage level allow students to develop the knowledge, skills, and understanding needed to reach the Target. Testlets at the Precursor linkage level and Target linkage level are most often computer-delivered and are typically taken by the student on the computer. More information about teacher-administered and computer-delivered testlet types comes later in this manual, beginning on page 72.

Table 8 is an example of a middle school physical science Essential Element with the corresponding linkage levels. Notice the reduced expectation in breadth, depth, and level of complexity from linkage level to linkage level. Also, observe the embedded practices, which focus on carrying out investigations.

Table 8

Middle School Physical Science Essential Element With Corresponding Linkage Levels

Essential Element: EE.MS-PS2-2
Target level: Investigate and predict the change in motion of objects based on the forces acting on those objects.
Precursor level: Investigate and identify ways to change the motion of an object (e.g., change an incline’s slope to make an object go slower, faster, farther).
Initial level: Identify ways to change the movement of an object (e.g., faster, slower, stop).

ABOUT THE KITE SUITE

The Kite® Suite is an online testing interface. It was designed to deliver the next generation of large-scale assessments and was tailored to meet the needs of students with the most significant cognitive disabilities, who often have multiple disabilities. Educators and students will use different parts of the Kite Suite.



Students have accounts in **Kite Student Portal**, the customized, secure interface where students take their assessments. Practice activities and released testlets are also available in Student Portal, using demo usernames and passwords. Once the Student Portal app is launched, other websites or other applications cannot be accessed during the assessment.

Every year, the most current version of the Student Portal app must be installed on the student’s testing device. To install Student Portal and view supported platforms, use the links found on the [Kite Suite](#) page on the DLM website. A browser version of Student Portal **cannot** be used when assessing students.

Each student has their own unique username and password. A student’s username remains the same from year to year; but for security purposes, each year when the student is enrolled in Educator Portal, the student is assigned a brand-new password. Either the student signs into Student Portal themselves, or their test administrator signs in for them.

Educators and staff do not have accounts in Student Portal.



Staff and educators have accounts in **Kite Educator Portal**.

Educator Portal is the administrative application where educators manage student data and retrieve reports and extracts. Educators will access Educator Portal online using a supported browser. For information about working within Educator Portal, go to the EDUCATOR PORTAL USER GUIDE on the DLM website.

HOW TO USE THE DLM WEBSITE

HOW THE ASSESSMENT SYSTEM WORKS

OVERVIEW

The Dynamic Learning Maps® (DLM®) alternate assessment is designed to help plan and track a student’s learning throughout the year. The assessment occurs in two windows: the fall and spring.

English language arts (ELA) and mathematics assessments are required during both the fall and spring windows. Test administrators should embed each ELA and mathematics testlet within instruction. In this way, assessment informs instruction and benefits students. The results from the ELA and mathematics testlets taken by a student during both the fall and spring windows contribute to a student’s end-of-year Individual Student Score Report.

Table 10, Table 11, and Table 12 provide an at-a-glance overview of the requirements by subject and by window.

NOTE: Check your state’s webpage to determine if your state tests DLM science.

TESTLETS

Students with the most significant cognitive disabilities who qualify for the DLM alternate assessment require extensive, repeated, and individualized instruction and ongoing support that is not temporary or transient. These students often have difficulty retaining information in working memory for extended periods of time. Therefore, testlets were created to be brief, containing only a few items. Each testlet begins with an engagement activity designed to activate prior knowledge, motivate the students, and provide a context (Sinharay et al., 2014).

These small testlets were created to be delivered to students over a period of several weeks to avoid placing undue stress upon the students and to best meet their needs. The long assessment windows allow continued instruction to occur throughout the windows. Assessing the student should be individualized and should not be conducted in a group

setting, as is done with standardized assessments for students who are assessed on the general education standards.

The DLM alternate assessment is delivered in testlets in Kite® Student Portal. Each testlet includes an engagement activity at the beginning of the testlet, followed by items. Most testlets have three to five items. Each testlet assesses only one Essential Element, except for the testlet assessing the writing Essential Elements. This testlet assesses all writing Essential Elements for the grade in a single writing testlet.

Later in this manual, more details about the contents of testlets are available in the sections titled Computer-Delivered Testlets and Teacher-Administered Testlets.


HINT: During the fall window, at least one assessment at each linkage level is available for each ELA, mathematics, and science Essential Element. Once a student has tested an Essential Element at a linkage level, another testlet for the same Essential Element and same linkage level may be available. If another testlet is not available, this message will display: “Testlets are not available for this linkage level at this time.”

THE CYCLE OF INSTRUCTION, ASSESSMENT, AND EVALUATION

The DLM Alternate Assessment System was designed with each student’s unique needs in mind. These small testlets were created to be delivered to students over a period of several weeks to avoid placing undue stress upon the students and to best meet their needs. The assessment also allows continued instruction to occur throughout the state’s assessment window.

Students with the most significant cognitive disabilities are best able to demonstrate what they know and can do when a cyclical approach to their instruction, assessment, and evaluation is used, as opposed to being assessed at the end of a semester or school year on a mass of instruction they must recall from prior weeks and months. The Instructionally Embedded model of the Dynamic Learning Maps alternate assessment encourages this cyclical approach by giving teachers the opportunity to choose an Essential Element and linkage level, develop and deliver instruction for the chosen Essential Element, and then assess the student when the teacher determines the student is ready (Figure 4).

Essential Elements that meet the blueprint requirements for ELA and mathematics can be thoughtfully and strategically combined in units at the teacher’s discretion for instruction and then assessed at the appropriate time following instruction throughout the fall window. This cycle of instruction, assessment, and evaluation is repeated during the spring window.

The same set of Essential Elements that were taught and assessed during the fall window can be reassessed during the spring window, or other Essential Elements from the blueprint can be chosen. The choice is based on the teacher’s professional judgment of the student’s academic needs. The student’s Fall or Spring Performance Report may be used at any time within the cycle to evaluate if additional instruction is needed or if the student is ready to move on to another linkage level or Essential Element.

GUIDELINES FOR USING THE INSTRUCTION AND ASSESSMENT PLANNER IN THE FALL WINDOW

ELA AND MATHEMATICS IN THE FALL WINDOW

During the fall window, students are required to meet the blueprint requirements for English language arts (ELA) and mathematics, using instructionally embedded assessments. Instruction and testing are cyclical during the window. The test administrator selects an Essential Element for instruction, selects the linkage level, and provides instruction to the student outside of Educator Portal. After instruction, the test administrator assigns the testlet and delivers it in Student Portal.

After the student completes the testlet, the results are immediately available, except for the writing testlet, which is evaluated and scored outside of the Kite® system, and results are not available until the student's Individual Student Score Reports become available. For the other Essential Elements, the test administrator can check the Instruction and Assessment Planner to find out if the student mastered the Essential Element at the linkage level tested. The test administrator then makes decisions about the next Essential Element and linkage level based on the student's instructional needs, the IEP, and the need to meet the blueprint requirements during the window. The cycle should be repeated until the blueprint requirements are met.

NOTE: Bunch testing several Essential Elements at the end of the window is strongly discouraged.

Essential Elements that are available for assessment are in the current blueprints found in the Instruction and Assessment Planner and the Dynamic Learnings Maps® (DLM®) webpage for each state. Within the blueprint options and the blueprint coverage requirements, the test administrator selects Essential Elements on which to provide instruction to a student, followed by assessment. A test administrator may choose to instruct and assess more Essential Elements than are required for blueprint coverage. However, before the window closes, the blueprint requirements must be met. Some states have additional requirements. Check with your assessment coordinator about requirements for your state.

Supporting procedures for Educator Portal are in the section titled Use the Instruction and Assessment Planner in the EDUCATOR PORTAL USER GUIDE.

SCIENCE ESSENTIAL ELEMENTS IN THE FALL WINDOW

Science Essential Elements are available for instruction and assessment in the fall window. Testing is optional, and meeting the science blueprint is not required. In the fall window, test administrators follow a similar process for science as they do for ELA and mathematics. They choose an Essential Element and linkage level, provide instruction, assess the student, and evaluate the results. Mastery results from the science assessments are found in the Instruction and Assessment Planner. They are also available in the Fall Performance Report or the Student Progress Report, but the results from the fall window for science are not included in the end-of-year Individual Student Score Reports.

NOTE: Check your state’s webpage to determine if your state tests DLM science.

LINKAGE LEVEL RECOMMENDATIONS FOR THE FALL WINDOW

At the beginning of the fall window, the results of the First Contact Survey are used in the Kite system to recommend a linkage level for each Essential Element in the Instruction and Assessment Planner for ELA, mathematics, and science. The linkage level is intended to provide an appropriate challenge for the student and represents a good instructional target. The test administrator may select the system-recommended linkage level or choose a different one.

HINT: The test administrator will not be able to select an Essential Element or linkage level until the student’s First Contact Survey is submitted.

REVIEW AND REVISE CHOICES IN THE FALL WINDOW

In the fall window, test administrators may review and revise their choice(s) of Essential Elements for all subjects for a student on the Student View Page in the Instruction and Assessment Planner. The test administrator may decide to not proceed in testing the student on a selected Essential Element or linkage level after instruction. The selected Essential Element or linkage level can be changed up until the test administrator has assigned the testlet. If an assigned testlet needs to be canceled, the district assessment coordinator can cancel the testlet.

RETRIEVE INSTRUCTIONAL INFORMATION IN THE FALL WINDOW

Instructional information is available using the mini-map for each Essential Element that a test administrator selects in the Instruction and Assessment Planner.

MINI-MAPS

The mini-map is a resource that shows the link between the grade-level standard and the Essential Element. The Essential Element is first described and then further broken down into linkage level descriptions. The Essential Element is then broken down further into nodes, with the description of each node and how one node is connected to the next node. Using the nodes, a teacher can build skills during instruction with the student before the student is ready to be assessed on the Essential Element.

The mini-map is readily available within the Instruction and Assessment Planner by selecting the mini-map icon for the Essential Element. However, if the testing window has not yet opened, the mini-maps and the subjects your state uses for assessment can also be found on the DLM state webpage for each subject:

PROFESSIONAL DEVELOPMENT MODULES

Professional Development modules are located on the [DLM Professional Development](#) website. These modules focus on instruction in the areas of ELA, mathematics, and science, while also providing important information regarding components of the DLM Alternate Assessment System. The modules are part of the instructional professional development system.

The modules are available in two formats: self-directed and facilitated. The self-directed modules are short (30–45 minutes on average) and focus on a single topic. The facilitated versions have videos, activities, and handouts and are designed for a group. Each module is followed by a short quiz. After passing the quiz, a certificate of completion is sent to the email address that the participant provided. The participant should download, print, and save the certificate for their records. Some states provide continuing education credits for these modules. Check with your assessment coordinator about this possibility.

OTHER INSTRUCTIONAL RESOURCES


Other instructional resources also can be accessed from the [DLM Professional Development](#) website. The teacher will find text resources, communication supports, writing resources, lesson supports, and resources to provide teachers with enhanced descriptions of the Initial and Distal Precursors for the most frequently used Essential Elements.

ASSIGN A TESTLET IN THE FALL WINDOW

After instruction is complete and the student is ready for assessment, the test administrator returns to the Instruction and Assessment Planner and assigns the testlet for the Essential Element at the selected linkage level (Figure 5). By choosing to assign a testlet to the student, the testlet becomes available in Student Portal, and its Testlet Information Page (TIP) becomes available in the Instruction and Assessment Planner. If needed, the test administrator has the option not to assign a testlet for an Essential Element.

Sometimes, a teacher may decide not to assign a testlet for an Essential Element. By choosing **Instruction Complete, Do Not Assign Testlet**, the Essential Element at that linkage level will revert to its original unused status.

SCHEDULE AND ARRANGE ASSESSMENT SESSIONS

The test administrator schedules the testing sessions for all three subjects during both windows. Several sessions during each window will likely be needed, including additional make-up sessions in case a student is absent or not engaged in the assessment on the originally scheduled days. Testing should be scheduled throughout the window and not bunched together at the end of the window.

Evaluating a student's current behavior is very important in assessment. Not every day is a good day to assess. Therefore, use professional judgment and reschedule the assessment if a student is not having a good day on the intended assessment day. If the student gets tired or distracted during a testlet sooner than expected, allow the student to complete and submit the testlet and then take a break from testing until the student is ready again. You can also use the **EXIT DOES NOT SAVE** button and return later (if your state allows this option). If **EXIT DOES NOT SAVE** is chosen during a testlet, any responses the student has made up to that point will not be saved. The testlet will revert to the unused status. When the student is ready again, testing can begin afresh.

Testlets may be administered in a classroom, computer lab, multipurpose room, or other school setting. However, the space must be quiet, free from distractions, and located where the testlet is not visible to other students. The test administrator must supervise the students during testing; students are not permitted to take testlets remotely on their own (e.g., at home). Testing is designed to be individual, not group testing.

Recommendations for configuration of the computer, test administrator, student, and other materials are provided in Computer-Delivered Testlets on page 72 and Teacher-Administered Testlets on page 86 of this manual.

For assessment time averages and ranges, go to Duration of the Assessment Administration on page 51 of this manual.

PREPARE TO ADMINISTER A TESTLET

Test administrators need the following when administering an assessment in each window:

- An assessment device loaded with the most current version of Kite Student Portal
- The student's username and password; these are available in the Instruction and Assessment Planner and are the same for both windows and for all subjects, including field test testlets. Although a student's username remains the same from year to year, each year when the student is enrolled in Educator Portal, the student is assigned a brand-new password.
- Assistive devices appropriate to the student (if applicable)
- Headphones for computer Spoken Audio if other students are in the room (if applicable)
- TIP for the Essential Element being tested

RETRIEVE TESTLET INFORMATION PAGE AND GATHER MATERIALS

TESTLET INFORMATION PAGES (TIPS)

To be prepared for test administration, the test administrator must access the TIP (Testlet Information Page) for each testlet before beginning the test session.

Test administrators can find specific information for each testlet in its TIP. Test administrators access the TIP by selecting the icon after a testlet is assigned to a student. Test administrators must review the TIP before beginning the student’s assessment. After the testlet has been delivered to the student, the TIP is no longer available in the Instruction and Assessment Planner. If a TIP was printed, it must be securely destroyed. Sample TIPs are available for all three subjects in teacher-administered, computer-delivered, and braille. Go to [Instructional Resources](#) | select a subject | Testlets | Sample Testlet Information Pages. The PDF resource, About Testlet Information Pages, is also available, which explains all the sections in a TIP.


HINT: During the fall and spring window, the TIPs for ELA and mathematics field test testlets are only available in the Test Management section of Educator Portal.

The testlet form name is included in the TIP (outlined in red in Figure 6). The following example is a TIP for an ELA assessment of reading informational text for Grade 11 or 12 for a testlet at the Initial Precursor level. The last four numbers are this testlet’s ID: 7125.

Information on the TIP states whether a testlet is computer-delivered or teacher-administered and indicates the number of items on the testlet. The TIP for a teacher-administered testlet typically has information regarding materials that need to be gathered for use during testing. The materials for a computer-delivered testlet are typically all on the computer screen. However, the TIP for a computer-delivered testlet may have restrictions listed (e.g., a calculator may not be permitted for a particular mathematics testlet).

The TIP also provides the following information for each testlet:

- **Materials Needed:** This field contains a list of the materials needed to administer the testlets. A description of any necessary attributes of the materials is provided. For example, the materials may be three different small objects that are familiar to the student, each of which has a single-word name (e.g., ball, pencil, and bag).

- **Materials Used:** This field contains a description of how the materials are used in the testlet to assess the skill. For example, the student will be able to indicate a specific object when the object's name is used.
- **Suggested Substitute Materials:** This section indicates whether materials may be substituted. Sometimes in this section, a test administrator will also find the recommended key attributes of substitute materials. Substitute materials are usually allowed.
- **Accessibility Supports Not Allowed:** Although a test administrator may usually use all Personal Needs and Preferences (PNP) Profile supports and take advantage of the flexibility described in the Practices Allowed section of this manual, the TIP will indicate when a support is not allowed (e.g., a calculator, or if other limits are included, like when definitions or translations are not allowed).
- **Other Comments:** If a testlet has other unique instructions, they will appear here. Some testlets require special setup before test administration; for example, some mathematics testlets designed for students who are blind or have visual impairments have additional pages of instructions.
- **Alternate Text:** For test administrators who will be delivering a testlet with images (either in the text, engagement activity, items, or picture-response cards), alternate text descriptions of the images are provided as additional pages after the main TIP pages for human read aloud.

TIPS FOR ELA TESTLETS

TIPs for ELA testlets provide the following information:

- The name of the text
- Whether the text is informational or literature-based
- Whether the text is familiar or unfamiliar (familiar texts may be downloaded from the [Instructional Resources page](#) on the DLM website and used in classroom instruction prior to assessment)*
- Name of the grade-level text associated with the DLM alternate assessment text

*Teacher-administered reading testlets use texts that should have been used during instruction and are familiar to students. If the student is accustomed to having the familiar text read from a paper copy, the paper copy may be used during assessment. Links to printable versions of familiar texts are provided on the [Instructional Resources](#) page of the DLM website. Choose a grade level to access all texts for that grade.

For instructions to download and print a familiar text, use Appendix B: Downloading or Printing DLM Familiar Texts.

TIPS FOR MATHEMATICS TESTLETS

TIPs for mathematics testlets provide the following information:

- Any specific mathematics terminology used in the testlet
- Instructions for setting up mathematics testlets for students who are blind or visually impaired
- Whether calculator use is allowed for the testlet:
 - “Yes” means a student can use a calculator if the student is accustomed to using a calculator for instruction. Some items in the testlet may not require a calculator, but the test administrator does not have to remove the calculator once it has been given for the testlet.
 - “No” means a student cannot use a calculator for any portion of the testlet.
 - “Not Applicable” means the items do not involve computation and a calculator does not need to be provided.

TIPS FOR SCIENCE TESTLETS

TIPs for science testlets provide the following information:

- Any materials that should be gathered prior to the assessment
- Picture-response cards for testlets at the Initial linkage level that **must** be printed prior to the assessment, since they are used during the assessment. Best practice is to print picture-response cards in color.
- Objects for testlets at the Initial linkage level that **must** be gathered prior to the assessment, since they are used during the assessment

Calculators are not allowed for any science testlets.

MATERIALS FOR ELA, MATHEMATICS, AND SCIENCE

Materials used in testlets should be familiar to the student and are typically readily available. The TIP includes descriptions of the general material properties that are needed to correctly assess the Essential Elements at a linkage level. Materials that are not listed may be substituted if they meet the general requirements for that assessment. Also, if a testlet assigned to the student contains materials that are not appropriate for that student, substitutions can be made.

Materials for the testlet must be collected prior to the assessment session. However, if the student has begun a testlet and the materials are not working as anticipated, test administrators can pause testing and retrieve alternate materials. Student Portal can be inactive for up to 90 minutes before timing out. Go to System Timeout on page 84 of this manual for more information about the 90-minute timeout.

Lists of common materials used in testlets, particularly the teacher-administered testlets, are found for each subject in the Materials Collections lists on the DLM website. Go to [Instructional Resources](#) | select the subject | Collections. Separate lists are provided for each window for each subject. Review and become familiar with the lists. However, not everything on the lists will be needed. That is why downloading the TIP ahead of time is so important, since the TIP lists the materials needed for the specific testlet.

DURATION OF THE ASSESSMENT ADMINISTRATION FOR ELA, MATHEMATICS, AND SCIENCE

The time to complete a testlet varies depending on each student's unique needs. The average duration of the assessment in minutes per testlet during the fall and spring windows is in Table 13.

Table 13

Average Duration of the Assessment in Minutes per Testlet During the Fall and Spring Windows

Subject	Average duration in minutes per testlet*
ELA Reading	10–15
ELA Writing	10–15
Mathematics	5–10
Science	5–15

*Average duration **does not** include the preparation time needed by the test administrator.

NOTE: Check your state's webpage to determine if your state tests DLM science.

Total time varies depending on the number of Essential Elements necessary to meet the blueprint coverage requirements for the grade and the number of Essential Elements a test administrator chooses for assessment.

FIELD TEST TESTLETS

The naming convention for each subject's field test testlets will begin with **FT** (e.g., **FT SP ELA RL.3.1 IP 123**).

FALL WINDOW

- After completing the blueprint requirements for ELA and mathematics, the student may receive zero or one field test testlet in each subject.

- The linkage level may be one above, one below, or the same as the operational Essential Element that was tested.
- The TIP is in the Test Management section of Educator Portal.
- The field test testlets are taken in Student Portal.
- Science will not have field test testlets in the fall window.

SPRING WINDOW FOR ELA AND MATHEMATICS

- After completing all blueprint requirements for ELA and mathematics, the student may receive zero or one field test testlet in each subject.
- The linkage level may be one above, one below, or the same as the operational Essential Element that was tested.
- The TIP is in the Test Management section of Educator Portal.
- The field test testlets are taken in Student Portal.

SPRING WINDOW FOR SCIENCE 2026

- In spring 2026, DLM will administer field tests testlets for the updated Essential Elements that will be used for the operational assessment beginning in the 2026–2027 school year.
- Students will be taking a total of four science field test testlets. They will be delivered in two science field test forms, each containing two field test testlets. The forms will be available when the first operational science testlet is assigned.
- The field test testlets can be taken any time before the closing of the spring window.
- Subsequent operational testlets will continue to be delivered after the previous testlet is completed, regardless of whether the field test forms have been completed.

MONITOR PROGRESS TOWARDS MEETING BLUEPRINT REQUIREMENTS

In each assessment window, students are expected to meet blueprint requirements for every ELA and mathematics claim and conceptual area. Test administrators can easily monitor progress toward meeting those requirements on the Student View Page in the Instruction and Assessment Planner; a white checkmark in the green circle in the upper-right corner is displayed with the word *Complete* when the blueprint requirement has been met in the claim and conceptual area (Figure 7).

In Figure 7, the checkmark is displayed in the upper-right corner indicating the blueprint requirement was met for Claim ELA.C1 *Students can comprehend text in increasingly complex ways* and Conceptual Area ELA.C1.2 *Construct Understandings of Text*. In that conceptual area, the student only had to be tested on one Essential Element—either a language, a reading literature, or a reading informational Essential Element. Even though the

student did not master the Essential Element at the linkage level tested, the blueprint requirement for the claim and conceptual area was still met.

Also, in the fall window, the Student Activity Table will display the status of blueprint requirement completion for ELA and mathematics (Figure 8). Because science is optional in the fall window, “NA” displays in the table for blueprint requirements met.

Gray-shaded steps are described in more detail in this section of this manual. Other steps are defined in the other DLM resources listed in the Checklists for Test Administrators on page 13 of this manual.

AGREE TO THE SECURITY AGREEMENT

Test administrators are expected to deliver the DLM alternate assessment with integrity and to maintain the security of testlets. The security agreement expires the first week of August every year and must be renewed annually in Educator Portal. Test administrators must read and agree to the security agreement, and then select Save. Figure 9 is an example of the security agreement text.

The Kite Suite provides opportunities for flexible assessment administration; however, all assessments delivered during the school year are secure. Test administrators and other educational staff who support implementation are responsible for following the Kite test security standards:

1. Assessments (testlets) are not to be stored or saved on computers or personal storage devices; shared via email or other file sharing systems; or reproduced by any means.
2. Except where explicitly allowed as described in the Test Administration Manual, electronic materials used during assessment administration may not be printed.
3. Those who violate the Kite test security standards may be subject to their state's regulations or state education agency policy governing test security.
4. Educators are encouraged to use resources provided by Kite Suite, including practice activities and released testlets, to prepare themselves and their students for the assessments.
5. Users will not give out, loan or share their password with anyone. Allowing others access to an Educator Portal account may cause unauthorized access to private information. Access to educational records is governed by federal and state law.

Questions about security expectations should be directed to the local assessment coordinator.

NOTE: If DLM staff discover that an account has been accessed by someone other than the account owner, the account will be considered compromised and will be sequestered until the state assessment administrator contacts the DLM Service Desk requesting the account be reopened.

Contact your assessment coordinator for additional guidance on test security in your state and district and for procedures for reporting assessment irregularities.

COMPLETE TRAINING AND PROFESSIONAL DEVELOPMENT

The DLM program provides required training for test administrators, professional development for instructional support, and supplemental training (Table 15).


NOTE: Your district assessment coordinator may provide a training plan tailored to your state and for training beyond what is provided by the DLM alternate assessment.

REQUIRED TEST ADMINISTRATOR TRAINING

Test administrator training is required for any educator administering the DLM alternate assessment. State policy determines

- the roles in Educator Portal that are automatically enrolled for the required training
- the courses that are offered (new Test Administrator Required Training, returning Test Administrator Required Training, or both)
- the course format that is to be used (self-directed, facilitated, or both)

After a test administrator signs into Educator Portal, they access the Required Test Administrator Training by selecting the Training tab on the home screen in Educator Portal. Separate login credentials are not needed to access training.



The course content is consistent across the DLM states. In all states, educators assigned the Educator Portal role of Teacher are automatically enrolled in required training.

Test administrators who will be administering the DLM alternate assessments for the first time are enrolled in the new Required Test Administrator Training course. Test administrators who administered the assessments in the immediately preceding year are typically enrolled in the returning Required Test Administrator Training course. A returning test administrator is identified from Educator Portal records. Sometimes, due to state policy, a returning test administrator is required to take the course for new test administrators.

HINT: Go to the [Guide to DLM Required Test Administrator Training for Instructionally Embedded Model States](#) located on your state's DLM webpage.

The training for new test administrators consists of four modules that must be completed in order. Only the first module in the course is initially available. Each module ends with a post-test, which must be passed with a score of 80% or higher before the next module becomes available. If a post-test is not passed, test administrators must repeat the module

and its post-test as many times as needed until a score of 80% or higher is achieved for the module.

If a test administrator is unable to complete all four modules in one sitting, after completing a module, they can sign out. Then, when ready to begin again, they sign back into Educator Portal, select the Training tab, select the course name, and begin the next available module. When all modules are successfully completed, participants receive a certificate of completion, which they **must** select, or they will not be able to test any students. They are strongly advised to download, print, and save their certificate.

The four required modules in the new Required Test Administrator Training course are as follows:

- 1) Overview of the DLM Assessment System
- 2) Understanding and Delivering Testlets
- 3) The Instructionally Embedded Model
- 4) Becoming Familiar with DLM Resources

The returning Required Test Administrator Training course consists of only one module, which takes approximately one hour and is available only in the self-directed format. This module is a review of the four modules in the course for new test administrators. The returning course ends with a post-test. The post-test must be passed with a score of 80% or higher on the **first** attempt. If unsuccessful, additional training in the applicable section(s) will be required. The additional training may take 30 minutes or up to 2.5 hours, depending on the section(s) that must be repeated. When this module is successfully completed, participants receive a certificate of completion, which they **must** select. They are strongly advised to download, print, and save it.

New Required Test Administrator Training is available in a self-directed format, a facilitated format, or both formats, depending on the state administrator's decision. All post-tests must be completed. If the required training is delivered in the facilitated format, the test administrator must sign in to Educator Portal, select the Training tab, and take each post-test.

Along with the required training, states may also include additional short helplet videos and one or more professional development modules to assist test administrators.

More information about the contents of each module, training formats, and procedures for completing required training is provided in the [Guide to DLM Required Test Administrator Training for Instructionally Embedded Model States](#) on the DLM website.

PROFESSIONAL DEVELOPMENT FOR INSTRUCTIONAL SUPPORT

Professional development for instruction is strongly encouraged. Modules focus on teaching students who have the most significant cognitive disabilities in the areas of English language arts (ELA), mathematics, and science, plus several foundational topics. Other modules provide important information regarding components of the DLM Alternate Assessment System. The modules can be taken as an online self-directed course or as a facilitated course in a group.

- Each online, self-directed module lasts approximately 30 to 45 minutes and focuses on a single topic related to instruction. Post-tests accompany the modules.
- Facilitated modules for groups cover the same content as self-directed modules and have a post-test to complete.
- Instructional resources provide lesson supports, writing resources, and enhanced descriptions of the Initial Precursor and Distal Precursor for the most frequently used Essential Elements. The descriptions provide a clear connection between the Initial Precursor, Distal Precursor, and Target linkage levels.
- Most educators are required to participate in regular, ongoing professional development. Some state agencies give continuing education credits for the DLM professional development modules. If your state gives continuing education credits, then upon completion of each professional development module, print the certificate that is emailed to you and provide the documentation to your assessment coordinator.

SUPPLEMENTAL TRAINING

Supplemental training materials include short helplet videos on common Educator Portal procedures and best practices (e.g., [Getting Started in Educator Portal](#) and [Science Test Tickets and TIPS in the Spring Window](#)). Go to your state's DLM webpage | filter by Teacher role | Assessment Resources | scroll to [Educator Resource Videos for Instructionally Embedded States](#).

REVIEW STUDENT DEMOGRAPHIC INFORMATION

Test administrators must have an accurate list of students for whom they are responsible. Before each assessment window, test administrators must review the student names that appear on their rosters in Educator Portal. Check with your assessment coordinator for review deadlines and the procedures for correcting records.

Questions to ask include the following:

- Do all my eligible students appear on my list of students?
- Is each student assigned to the correct grade?

- Are there any students on my list who are not assigned to me or who are not eligible for the DLM alternate assessment?
- Do any student records have typos or misspellings?

If any errors are discovered, ask the assessment coordinator to make corrections. Some student information will be in the student's end-of-year Individual Student Score Report (e.g., the student's name). Having the information presented correctly will be important to students and their parents or guardians.

Detailed procedures for checking this information are in the Manage Student Data section of the EDUCATOR PORTAL USER GUIDE.

NOTE: The student must be enrolled in the correct grade for grade-appropriate testlets to be delivered in Student Portal. If a student was enrolled in the incorrect grade and has started testing, after the student's enrollment record is corrected, the student will need to begin testing all over again. Previously completed testlets may no longer be available.

ACCESS THE INSTRUCTION AND ASSESSMENT PLANNER

The Instruction and Assessment Planner is a section in Educator Portal where test administrators create plans for their students' instruction and then assign testlets. In the Instruction and Assessment Planner, the test administrator will be able to do the following:

- Review student data to ensure students are rostered correctly and their demographic information is accurate
- Submit the First Contact Survey
- Choose suitable supports in the PNP Profile, if needed, and save them
- Select Essential Elements for instruction and testing
- Select the appropriate linkage level
- Access the mini-map for instructional support
- Assign a testlet
- Access the TIP for the testlet
- Access the braille ready file (BRF) if braille was selected in the PNP Profile for the student, and if a BRF is available for the Essential Element and linkage level
- Retrieve the credentials for the student (username and password)
- Administer the testlet
- Review testlet results in the Instruction and Assessment Planner
- Print the Fall or Spring Performance Report for each student in each applicable subject, if desired. These reports must be handled securely.

Step-by-step procedures are available in the Use the Instruction and Assessment Planner section in the EDUCATOR PORTAL USER GUIDE.

COMPLETE OR UPDATE THE PERSONAL NEEDS AND PREFERENCES PROFILE

The DLM alternate assessment offers a variety of accessibility supports, which can be selected in a student's PNP Profile in Educator Portal. The ACCESSIBILITY MANUAL describes a six-step process for evaluating and choosing appropriate supports for each student. Go to the section titled Six Steps to Customize Dynamic Learning Maps Accessibility Supports for Students in the ACCESSIBILITY MANUAL.

Most states provide guidelines that their IEP teams are required to use when making decisions about accessibility supports for a student during testing. Some states provide their state-specific guidelines as an appendix in the ACCESSIBILITY MANUAL on their DLM state webpage.

Accessibility supports in the student's PNP Profile in Educator Portal include those required to meet the student's needs in their IEP and other supports for which a student may show a preference but are not required in the IEP. Some supports become available in Student Portal after they are selected in the PNP Profile (e.g., magnification). Other supports selected in PNP Profile are provided outside the system (e.g., calculator). Test administrators should review accessibility supports with the IEP team at least once per year.

If the original PNP Profile selections do not allow the student to fully access the content of the testlets as expected, the test administrator may adjust accessibility selections listed in the PNP Profile between testlets to provide more appropriate supports. Go to the ACCESSIBILITY MANUAL, in the section titled Changing PNP Profile During Testing, for help in changing PNP Profile settings. The assessment coordinator can provide further IEP guidance if needed.

Procedures for choosing suitable supports and saving the PNP Profile settings in Educator Portal are in the EDUCATOR PORTAL USER GUIDE in the section titled Complete the PNP Profile.

COMPLETE AND SUBMIT THE FIRST CONTACT SURVEY

LINKAGE LEVEL RECOMMENDATIONS FOR ELA, MATHEMATICS, AND SCIENCE

The First Contact Survey is a series of items that goes beyond basic demographics and covers a variety of areas, including communication, academic skills, and attention. The test administrator enters the responses for each eligible student on their rosters.

Responses to the survey items are used to provide an optimal system match between the student and linkage level for each Essential Element in the blueprint for each subject being tested. The items are categorized into the following sections:

- Special Education
- Sensory Capabilities
- Motor Capabilities and Health
- Computer Instruction
- Communication (Expressive and Receptive)
- Language
- Academics

FALL WINDOW

When the fall window opens, the test administrator can easily open a student's First Contact Survey in the Instruction and Assessment Planner if the student has been rostered to them. The test administrator can respond to items in the survey, and then submit it. The data is analyzed and used to **recommend** the linkage level for each ELA, mathematics, and science Essential Element that could be chosen for assessment. After submitting the survey, refresh the screen, and then on the Student View Page, begin the Essential Element selection process. Accept the system-recommended linkage level or select a different one.

SPRING WINDOW FOR ELA AND MATHEMATICS

The student's performance on Essential Elements for ELA (except the writing Essential Elements) and mathematics that were tested in the fall window determines the recommended linkage level for those Essential Elements in the spring window. If an Essential Element was not tested during the fall window, the data from the student's First Contact Survey is used to recommend the linkage level. The test administrator may accept the system recommendation or select a different one for each ELA and mathematics Essential Element. The linkage level recommendation in the spring window for the writing Essential Elements is different from all other ELA Essential Elements.

NOTE: During the spring window, the linkage level recommendation for the writing Essential Elements is **always** based on the test administrator's responses to the writing items in the student's First Contact Survey and never on the student's performance on the writing testlet from the fall window.

SPRING WINDOW FOR SCIENCE

Only Essential Elements from the science blueprint are presented for testing. Either nine or 10 testlets will be delivered.

NOTE: Check your state's webpage to determine if your state tests DLM science.

Science testing during the spring window is different from science testing in the fall window, and it is also different from ELA and mathematics testing in the spring window. All test administration tasks for science are in the Test Management section of Educator Portal (e.g., downloading the TIP and test ticket, accessing a braille ready file [BRF], if applicable). The Kite system assigns the order in which the science Essential Elements are tested and assigns the linkage levels for each Essential Element. The test administrator cannot change those.

In addition, science assessments are adaptive in the spring window. The process is as follows:

- 1) The system assigns the first science Essential Element to be tested and assigns its linkage level.
- 2) The test administrator delivers the testlet to the student for that Essential Element in Student Portal. The testlet is scored, and the system then adapts, determining the linkage level assignment for the next science Essential Elements to be tested, which may be the same linkage level, or one level lower or higher.
- 3) The system's adaptive assignment continues until all nine or 10 science Essential Elements from the blueprint are tested.

RESOURCES FOR COMPLETING THE FIRST CONTACT SURVEY

Use the following resources for step-by-step instructions and guidance in completing the First Contact Survey and the PNP Profile. Test administrators can choose to complete these tasks in one of two places: by selecting the icons on the View Student screen in Educator Portal before the opening of the fall window or by selecting the icons in the Instruction and Assessment Planner after the opening of the fall window.

PREPARE FOR THE ASSESSMENT WITH PRACTICE ACTIVITIES AND RELEASED TESTLETS

Practice activities and many released testlets are provided to support educators and students preparing for the assessment.

- Practice activities are designed to familiarize users with how testlets appear in Student Portal. Two practice activities are for test administrators and two are for students.
- Released testlets are similar in content and format to operational DLM testlets.
- Access practice activities and released testlets using Student Portal in the practice section. Use demo student usernames and passwords provided in this manual to complete both types of activities as many times as desired. See Table 24 on page 130.

PRACTICE ACTIVITIES

Sign in to Student Portal with the demo usernames and passwords. Select **Other** (Figure 10).

NOTE: The practice activities are not subject-specific. They are designed to show how Student Portal functions.

TEACHER PRACTICE ACTIVITY

The teacher practice activity is a tutorial on testlets that are administered directly by the teacher. Teacher-administered testlets are used when the student has presymbolic communication and cannot interact directly with the computer, or when the content is difficult to assess on the computer (e.g., some higher linkage level mathematics testlets).

In this type of testlet, the teacher reads the instructions aloud on the testlet screens and follows them. The test administrator observes the student's behavior regarding the items and enters the responses that most closely align with the student's behavior. All activities or exchanges between the test administrator and student occur outside the system. Only the test administrator works on the computer. The test administrator may go forward and backward within a testlet as much as needed before submitting the responses.

Most teacher-administered testlets require test administrators to gather materials to be used in the assessment prior to the assessment. Testlet Information Pages (TIPs) list those materials. Remember that substitutions can be made as necessary, unless expressly noted in the TIP. Directions for how to prepare for the testlet are also provided as Educator Directions on the first screen of the testlet.

HINT: Practice activities and released testlets do not include TIPs. However, sample TIPs are provided on the DLM website. Go to [Instructional Resources](#) | choose a subject | Testlets | Sample Testlet Information Pages.

STUDENT PRACTICE ACTIVITY

The student practice activities are tutorials designed for students to practice navigating a testlet. Computer-delivered testlets are used when the content can be accessed directly by a computer, and when students can directly interact with the system by selecting their own responses and by using assistive devices or other supports as needed.

Students may navigate using a mouse, Tab and Enter keys on a keyboard, or switches. Students may navigate forward and backward within a testlet as needed before submitting responses. If a student can engage with the content but cannot advance the screens or input responses independently, a student and teacher may practice with the teacher navigating the screens and recording the responses on the student's behalf. Specific supports and practices that are not allowed are described further in the Practices Not Allowed section on page 107 of this manual.

Several types of items are available in student practice activities:

- **Single-select multiple-choice items:** The student selects one correct response.
- **Multiple choice-multi-select items:** The student selects all correct responses.
- **Matching items:** The student identifies how pairs of items are related to one another.

RELEASED TESTLETS

Released testlets are publicly available, sample DLM assessments. They are like actual operational testlets and are selected from a variety of Essential Elements and linkage levels from Grade 3 through high school. Each testlet contains items that align to Essential Elements at a designated linkage level. A released testlet is developed using the same standards and methods used to develop testlets that are used in DLM operational assessments. Newly released testlets are added periodically and may be used by students and teachers as examples or opportunities for practice and to ensure a student's assistive device will perform as expected.

Some released testlets are teacher-administered and some are computer-delivered. Teacher-administered testlets are typically at the lower linkage levels. Also, all writing testlets are teacher-administered. Computer-delivered testlets are typically at the higher linkage levels.

The usernames and passwords for released testlets are available on page 130 of this manual or can be found in the [Guide to Practice Activities and Released Testlets](#) on the DLM website.

HINT: Some released testlets are available in PDF format on the DLM website. These may be helpful to provide to parents and guardians. Student Portal does not have to be installed on a computer to view these testlets.

If you have questions or technical problems with the practice activities or released testlets, contact your assessment coordinator or local technology personnel.

In Student Portal, all testlets, including released testlets, are identified by subject, Essential Element, and linkage level (Figure 11).

A Testlet Name in Kite Student Portal



TROUBLESHOOT ACCESS IN EDUCATOR PORTAL



IMPORTANT:

Save time and avoid errors by completing these steps before assessing students.

NO ACCESS TO THE INSTRUCTION AND ASSESSMENT PLANNER OR TEST MANAGEMENT

Users with the role of Teacher in Educator Portal will not have access to the Instruction and Assessment Planner or the Test Management screen in Educator Portal until

- their state's window has opened
- rosters have been created that link their students to them
- they have passed all Required Test Administrator Training modules with a score of 80% or higher on each post-test

NO ACCESS TO THE STUDENT VIEW PAGE IN THE INSTRUCTION AND ASSESSMENT PLANNER

Test administrators will not have access to create plans or assign testlets to students on the Student View Page until their students' First Contact Surveys are submitted.

NO SCIENCE TESTLETS AVAILABLE

The same requirements for accessing the Instruction and Assessment Planner and Test Management described in the previous two paragraphs also apply to science testlet availability in the Test Management section of Educator Portal.

NOTE: To have science testlets available when the spring window opens, the First Contact Survey should be submitted at least 24 hours before the window opens. Also, the PNP Profile settings should be selected.

INTRODUCTION TO DYNAMIC LEARNING MAPS TESTLETS

COMPUTER-DELIVERED TESTLETS

OVERVIEW

Testlets delivered directly to students via a computer are designed with the assumption that students can interact independently with the computer. Students can use special devices as necessary, such as alternate keyboards, touch screens, or switches.

NOTE: Teacher-administered testlets will be described on page 86 of this manual.

Computer-delivered testlets in the Dynamic Learning Maps® (DLM®) alternate assessment are most common at the upper linkage levels, where the content being assessed is appropriate for delivery using the computer. Reading, mathematics, and science assessments include computer-delivered testlets.

Some students may test at upper linkage levels yet cannot interact directly with the computer due to physical limitations. For these students, the test administrator may navigate the screen on behalf of the student and enter the student's responses.

The Testlet Information Page (TIP) that accompanies each computer-delivered testlet may have few, if any, materials to be gathered since everything the student needs for taking the testlet is available on the computer screen. However, the TIP may have other pertinent information for the test administrator to know.

Writing testlets are **always** administered by test administrators outside of the system, even if the student normally receives computer-delivered testlets in English language arts (ELA). Writing testlets are described in the Teacher-Administered Testlets section beginning on page 86 of this manual.

HINT: Screenshots in the following sections of this manual demonstrate how a testlet is expected to appear on an assessment device. If a testlet is difficult to view on the assessment device, check the device's display settings and the screen resolution. The screen resolution should be 1024 × 768. Also, check the student's Personal Needs and Preferences (PNP) Profile settings to ensure the most appropriate settings have been selected. After doing this, if the issues cannot be resolved, contact your technology personnel or your assessment coordinator.

GENERAL STRUCTURE OF COMPUTER-DELIVERED TESTLETS

Testlets in ELA, mathematics, and science are each delivered differently based on research about effective instructional practices for students with the most significant cognitive disabilities. Testlets in all subjects begin with an engagement activity to motivate students, activate prior knowledge, and prepare students for the cognitive process required in the items.

Computer-Delivered ELA Reading Testlet Structure

Students taking DLM ELA testlets are assessed on both writing and reading skills. Although a writing testlet is always a teacher-administered testlet, a reading testlet can be either teacher-administered or computer-delivered, depending on the student.

During a reading testlet, students participate in two readings of a text. The first reading serves as the engagement activity and provides students with an opportunity to build a mental representation of the entire text before responding to items. The second reading includes items embedded within the text or placed at the end of the text, as appropriate.


NOTE: Occasionally, in a testlet at the Initial Precursor linkage level, an item is embedded within a text that does not assess reading comprehension of the text itself. Instead, the item addresses the linkage level skill for the Essential Element being assessed.

Foundational nodes represent the core skills and understandings necessary for students to engage in more complicated, content-based thinking and reasoning. Although items written to foundational nodes may be disconnected from the text in certain cases, these items are central to the progression through the ELA linkage levels for a given Essential Element and, more broadly, through the ELA learning maps for a given grade.

The first screen in ELA reading testlets directs students to read the text (Figure 12).


Instructions for an ELA Reading Testlet in Kite Student Portal



Students will read through the text. They may have the text read aloud by the computer if Spoken Audio is selected in the student's Personal Needs and Preferences (PNP) Profile (Figure 13). For all testlets, test administrators are permitted to read aloud to students. The student is then directed to read the text a second time and respond to items. Although some students taking computer-delivered reading testlets may require support to navigate from one screen to the next or to enter their responses, most students at the upper linkage levels will independently read the text and respond to the items.

An ELA Reading Testlet in Kite Student Portal Where Spoken Audio (The READ Icon) is Enabled




Computer-Delivered Mathematics Testlet Structure

Mathematics testlets start with an engagement activity that provides a context for the items (Figure 14). The engagement activity does not require a response. Mathematics testlets are built around a common scenario or activity to investigate related facets of a student's understanding of the targeted content as shown.

Computer-Delivered Science Testlet Structure

NOTE: Check your state's DLM webpage to determine if your state tests DLM science.

Science testlets begin with an engagement activity, just like testlets in ELA and mathematics. Each science testlet bundles together an engagement activity at the beginning of the testlet followed by three to five items. Science engagement activities can be one of four types:

- The first type of engagement activity is simply a single screen with one or two pictures along with a short sentence that introduces the science topic to be assessed. The items assess the Essential Element topic, not the engagement screen itself.
- A second type of engagement activity describes a scenario which taps prior knowledge or experience, introduces the concept to be addressed, and provides context for the items. The items assess information in the engagement activity and the Essential Element topic.
- A third type of engagement activity may be designed around a science story featuring an experiment or classroom activity that is presented twice, with items embedded within

the second presentation of the activity or at the end of the second presentation. The items assess information in the engagement activity and the Essential Element topic.

- The fourth type of engagement activity is a short, silent video (up to 30 seconds) and is only found in the upper grade bands and the upper linkage levels. Students will access the short video and then respond to three items that include still-frame photos from the video. The items assess information both from the video and the Essential Element topic.

NOTE: The entire video clip is completely silent.

The following is an example of a science story. The instructions at the beginning of the testlet describe to students what they will be doing in this testlet (Figure 15). In this science story, the student is to read the text and answer some questions.

Instructions for a Science Testlet in Kite Student Portal





Figure 16 is from a testlet where a short story is presented only once to the student. Although not shown, the testlet items follow the story on the next screen of the testlet.

COMPUTER-DELIVERED ITEM TYPES

Students may encounter a variety of item types when taking computer-delivered testlets. Most testlets are designed for students to interact directly with the computer.

ELA and mathematics testlets may include the following item types:

- Single-select multiple choice
- Multiple choice-multi-select
- Select text
- Matching or sorting: in a few upper linkage level testlets, students may encounter matching items

All science testlets are single-select multiple-choice items.

In general, the DLM alternate assessment uses the most straightforward item type that allows for quality assessment of the Essential Element. For this reason, complex item types are used only occasionally at upper linkage levels. The previously described practice activities and released testlets include one or more examples of the above item types.

The most common type of computer-delivered item is a single-select multiple-choice item with text response choices (Figure 17).





The final type of computer-delivered item that students might experience is select text. Select-text items are used only in some ELA assessments. Response choices are marked with a box around the word, phrase, or sentence. After the student selects their response choice, the outline around the word, phrase, or sentence becomes bold and the response

choice is highlighted in transparent yellow (Figure 21). To clear a selection, the student selects it again.

RESPONSE SELECTION FOR COMPUTER-DELIVERED ITEM TYPES

The procedures for selecting item responses in computer-delivered testlets are the same for all subjects. When the student first accesses an item, the responses will appear as shown in Figure 22.

Once a student selects a response, a box appears around the response choice (Figure 23). The student can select **NEXT** or **BACK** to navigate through the testlet screens. The response choice will stay selected.

No Response Option

All ELA and mathematics testlets at the Initial Precursor linkage level and all science testlets at the Initial linkage level include **No response** as a response option. The **No response** option is also included in some mathematics testlets at higher linkage levels where performance-based skills are being tested (e.g., measuring, counting). However, not all testlets include **No response** as one of the options.

No response is not a response option in computer-delivered testlets, because the understanding is that the students who are interacting with the computer are able to enter their response or are able to indicate their response to their test administrator to input into the computer. If a student does not provide a response for a computer-delivered item where a test administrator is inputting responses for the student, the test administrator should leave the item unanswered and move on to the next item. On the last screen, any unanswered items will be indicated by showing an “X” for that item number. The student can go back to the unanswered items and try again. However, even if the student provides no response for one or more items in a testlet, the testlet must still be submitted.

Whether **No response** is available for selection for an item or whether the item is left unanswered, the item is scored as incorrect. If the student usually produces an intentional response, but during a testing session does not do so (e.g., due to distractions or behavior

problems), and if state policy allows, the test administrator can use the **EXIT DOES NOT SAVE** button and begin the testlet again later when the student is more engaged.


System Timeout

The DLM alternate assessments are administered individually and are not limited to specific timeframes like most general education assessments. Any flexibility a student requires regarding the assessment time is permissible. A student may take as much time as needed and may work in settings that are most appropriate for them. However, if a student needs a significant break during the administration of a testlet, and if Student Portal sits inactive for as long as 90 minutes, Student Portal will time out.

This is how the system timeout works. After 88 minutes and 30 seconds of inactivity in the testlet, the system provides the student with this warning message: “Your session is about to expire. Select **Extend Session** to continue where you left off. Time Remaining: XX mins and XX seconds” (Figure 25).

- If no activity occurs before the countdown reaches zero, the system closes the testlet and returns to the login screen. The testlet status returns to **Unused**, and the system retains no answers.
- If **Extend Session** is selected, the system disregards the idle time, closes the prompt, and returns to the screen where the student had been working.
- If **Logout** is selected, the system closes the testlet and returns to the login screen. The testlet status returns to **Unused**, and the system retains no answers.

Educators sometimes question why answers are not saved when a testlet times out. Research has revealed that students with the most significant cognitive disabilities who qualify for the DLM alternate assessments require extensive, repeated, and individualized instruction and ongoing supports that are not temporary or transient in nature, and they

have difficulty retaining information in working memory for extended periods of time. Therefore, testlets were created to be short with only a few items.

Each testlet begins with an engagement activity that is designed to activate prior knowledge, motivate the student, and provide context. While DLM test administration procedures are designed to be flexible and allow students to take breaks during a testlet, most students who experience an extended interruption during test administration have difficulty retaining information in working memory after that extended interruption. Research has shown that an extended interruption during test administration can adversely affect student performance (Sinharay et al., 2014). Thus, Student Portal was designed to time out after an extended period of inactivity without retaining the responses, allowing the student to begin the assessment afresh when ready.

COMPUTER-DELIVERED ASSESSMENT ARRANGEMENT

Prior to test administration, evaluate how to arrange the computer or other assessment devices for the student and test administrator. All arrangements for computer-delivered testlets should maximize the student's independence and interaction with the computer.

Assessing students in a familiar environment is helpful, but the test administrator must ensure that the student is able to concentrate without distractions from other students.

Assessing students with the most significant cognitive disabilities should be individualized and not conducted in a group setting.

Maximize Student Interaction With a Computer-Delivered Testlet

The arrangement should maximize student interaction with the testlet using the computer or other assessment devices based on the student's needs. For instance, if the test administrator sits with a student, the student should sit directly in front of the computer and the test administrator should sit off to the side, as shown in Figure 26.

If the test administrator sits next to a student who can use the mouse without assistance, the test administrator should sit on the side of the student opposite from the mouse, so the student has space to move the mouse, and the test administrator is not tempted to move the mouse for the student. A student who takes the assessment on an iPad may be able to hold the iPad and respond to items independently. If not, the test administrator may hold the iPad in a position that provides maximum visibility for the student.

Maximize Student Independence

Although test administrators should continually monitor students, the assessment arrangement should maximize student independence and minimize test administrator involvement. For students who may need assistance during the assessment, the test administrator can sit close to the student to monitor the assessment. On the other hand, if the student can work independently, the test administrator should keep more distance while making sure the student takes enough time and responds to all items.

TEACHER-ADMINISTERED TESTLETS

OVERVIEW

All testlets at the lowest linkage level, some mathematics testlets at higher linkage levels, and all writing testlets are designed to be administered directly by the test administrator. In teacher-administered testlets, the test administrator is responsible for

- setting up the assessment
- delivering it to the student

- evaluating the student’s behavior in response to the items
- choosing the testlet response option that best describes the student’s behavior
- recording student responses in the testlet in Kite® Student Portal

GENERAL STRUCTURE OF TEACHER-ADMINISTERED TESTLETS

All teacher-administered testlets have some common features:

- The test administrator must be able to view the screen, read the instructions, and enter their observations of the student or the student’s responses.
- Directions and scripted statements guide the test administrator through the administration process.
- The TIP lists all assessment materials that the test administrator will need and must gather ahead of time. The TIP should be reviewed several hours or even a day or more before testing to enable the test administrator to be ready for test administration.
- The testlet includes an engagement activity and items.
- Teacher-administered testlets at the lowest linkage level include a **No response** item option.
- Science testlets at the Initial linkage level usually have objects that must be gathered or picture-response cards that must be printed ahead of time and used during testing. Best practice is to print these picture-response cards in color.

STANDARDIZED INSTRUCTIONS FOR ALL TEACHER-ADMINISTERED TESTLETS

Teacher-administered testlets are standardized. Anything in quotes and bold print must be presented verbatim to the student. Two exceptions to this rule are:

- When a material is substituted, the test administrator must then use the name of the substituted material when reading the item to avoid confusing the student.
- When the student uses sign language interpretation or language translation supports as allowable and described in the DLM ACCESSIBILITY MANUAL and on the TIP

NOTE: [Language translation is not allowable in some states. Ask your assessment coordinator if it is allowed in your state.](#)

SHOW AND SAY INSTRUCTIONS IN ALL TEACHER-ADMINISTERED TESTLETS

Test administrators will encounter two instructions for presenting items or directions to students: SHOW and SAY. However, because of hearing and vision limitations, some students may not be able to hear what is said, and others may not be able to see what is shown. SHOW means that the test administrator is allowed to present the materials to the student using sensory modalities appropriate for that student. SAY may require nonverbal communication appropriate for the student's sensory modalities, such as signing.

Figure 27 is an example of an item screen that may be embedded in the second reading of an ELA text. The Educator Directions tell how to interact with the student. The test administrator must read the lines presented in bold after SAY directly to the student. The administrator also must perform the actions for the student described after SHOW.

TEACHER-ADMINISTERED READING TESTLETS

In teacher-administered reading testlets, items focus on the cognitive skills that precede conventional literacy. These items are not traditional reading-comprehension questions, but instead are designed to assess the skills identified in the DLM learning map as critical precursors to reading for meaning. These types of items are embedded in the context of a

shared reading and are intended to mirror early literacy instruction. Items assess skills such as identifying familiar materials or identifying words that describe familiar people.

Shared reading strategies that an educator might use during the first reading of a text include the following:

- Encouraging engagement and interaction
- Discussing words
- Connecting words or pictures to a student's background knowledge and experience
- Labeling and pointing out pictures
- Modeling concepts about print (reading left to right, one-to-one correspondence between a spoken and written word, etc.)
- Pointing out rhymes, syllables, and sounds in words
- Asking questions to further engage students
- Modeling how to communicate using a student's communication methods
- Using a think-aloud process to model how to decide whether to make a comment
- Incorporating objects to help make connections

HINT: Text cannot be substituted with pictures or words from a word bank. For more information, go to the section Pictures, Symbols, or Use of a Word Bank on page 96.

STRUCTURE OF TEACHER-ADMINISTERED READING TESTLETS


First, the text is presented in its entirety. The test administrator reads the text aloud using shared reading strategies to maximize student engagement. Then, the text is presented again. This time, the test administrator must refrain from using shared reading strategies and instead focus on administering the items that are embedded in the second reading or placed at its conclusion. For more information about shared reading strategies, go to the professional development module titled [Shared Reading](#), which is available on the [DLM Professional Development website](#).

A teacher-administered reading testlet is often used at the Initial Precursor level, where students do not have the skills to directly interact with the computer. Teacher-administered reading testlets are also used for some testlets at higher linkage levels in the lower grades when the student is working with a familiar text.

Figure 28 is an example of the directions provided on the first screen in a teacher-administered reading testlet. This screen provides hints about a shared reading strategy. After this screen, the story screens begin.

The Beginning Educator Directions in a Teacher-Administered Reading Testlet in Kite Student Portal




In teacher-administered reading testlets, Educator Directions also appear between parts of the testlet (Figure 29).

The following is an example of a transition screen displayed after the test administrator has read a text with the student for the first time. The transition screen tells the test administrator that the first reading is over, and the second reading is about to begin. During the second reading, the student will respond to items embedded within the second reading or placed at its conclusion.

ALTERNATE TEXT FOR TEACHER-ADMINISTERED READING TESTLETS

Every TIP that is connected to a testlet with images (either in the text, engagement activity, or items) has alternate text. When administering a testlet to a student who uses human read-aloud support and/or requires verbal descriptions of images, use the alternate text available in the supplemental pages of the TIP. The alternate text pages of the TIP show the onscreen text and images for the first and second presentations of the text. Descriptions of the images are printed below the pictures and are labeled Alt Text (e.g., a picture of a dog is presented, then below the picture are the words, “Alt Text: a dog”). For students who require verbal descriptions of the images, read the text on the screen, then read the alternate text description exactly as it appears in the TIP.

ALTERNATE TEXT FOR MATHEMATICS AND SCIENCE TESTLETS

All testlets that have images (either in text, the engagement activity, items, or picture-response cards) have alternate text for the test administrator to use for students who are blind or visually impaired. The alternate text is in the TIP.

The only exception occurs when the alternate text provides a cue to the answer (e.g., if a student is asked to identify which shape is a triangle). The TIP would not include alternate text that named the shapes in the response options. In that instance, the alternate text page would instruct, “Do not describe.” The teacher would then rely on using objects, tactile

graphics, or individual tactile representations of pictures or objects presented onscreen for those students who are unable to rely on the images on the screen. Figure 18 on page 79 is an example of a mathematics testlet that has images as response options but would not have alternate text because the alternate text would cue the answer.

CLASSROOM SETUP FOR TEACHER-ADMINISTERED READING TESTLETS

The student, the test administrator, and the computer screen should be arranged in a triangle during a teacher-administered reading testlet. Both the student and test administrator need to have access to the text during the shared reading activity. The test administrator should have the best access to the directions pages and item screens. When the item screens appear, the test administrator needs to be able to enter responses easily. The triangle arrangement usually works, but the test administrator may need to shift position slightly so that screens containing the ELA text can easily be displayed to both student and test administrator. Leave space near the student for any materials that will be used.

TEACHER-ADMINISTERED WRITING TESTLETS

Every day in our classrooms, all students, including those with the most significant cognitive disabilities, are being prepared for life beyond their school years. A student's ability to communicate about their needs and wants is essential for safety and fulfillment in their adult life. Their ability to communicate includes being able to write in some meaningful way. Therefore, the writing Essential Elements and writing assessments were developed. Information about each writing Essential Element is available on your state DLM webpage. Go to [Instructional Resources](#) | Currently Tested Essential Elements in English Language Arts. The DLM writing testlet is used to assess students' mastery of the precursor skills that lead to writing and a student's ability to communicate using writing. These skills focus on understanding letters and words and the expression of ideas through words. Testlet response options that refer to "writing" or "the student wrote" can include any method the student uses for writing. The writing testlets all have some common features:

- Writing testlets are always teacher-administered and are required for every student in every grade.
- The student always works outside of Student Portal and interacts with the test administrator. Only the test administrator interacts with the testlet in Student Portal.


- To meet blueprint requirements for this claim and conceptual area, each student receives one writing testlet in the fall window and one writing testlet in the spring window.
- In both the fall and spring window, the system-recommended linkage level for the writing testlet is determined solely using information from the test administrator's responses to the items in the writing portion of the First Contact Survey, and not from the student's performance on any other testlets assessing other ELA Essential Elements.
- Writing testlets assess a combination of two to six writing Essential Elements, depending on the grade.
- Writing testlets are at one of two levels: emergent or conventional.

EMERGENT WRITING TESTLETS

- Emergent writing testlets are used for students who do not yet have, or are working on, early symbolic understanding.
- Emergent writing testlets are a combination of the Initial and Distal Precursor linkage levels (Figure 30).
- Students should use the orthography-based tools they use for writing during everyday instruction.
- Students in Grades 3–8 who are assigned the emergent writing testlet are assessed only on the writing process. These students are not expected to produce a written product.
- Students in high school who are assigned the emergent level writing testlets are also tested on the writing process, but these students are expected to produce a written product as well.
- The results for the writing testlet are only provided in the end-of-year Individual Student Score Report Results.

Process for an Emergent Writing Testlet




CONVENTIONAL WRITING TESTLETS

- Conventional writing testlets are for students who have symbolic understanding and can use more traditional writing tools to communicate.

- Conventional writing testlets combine linkage levels at the Proximal Precursor, the Target, and the Successor linkage levels.
- Conventional writing testlets are a little more typical of a traditional writing assessment (Figure 31).
- Students should use the orthography-based tools they use for writing during everyday instruction.
- Students taking conventional writing testlets are assessed on the writing process, but they are also expected to produce a written product.
- Many students taking the DLM alternate assessment will need a test administrator to assist them in obtaining a writing tool that offers them access to all 26 letters of the alphabet.
- DLM staff may request test administrators to electronically submit their student's final written product.
- The results (scores) for the writing testlet are only provided in the end-of-year Individual Student Score Report Results.

ALLOWED SUPPORTS FOR WRITING TESTLETS

The following supports **are allowed** for writing testlets:

- Pens, pencils, markers, crayons
- Whiteboards
- Traditional keyboards using word-processing software
- Adapted keyboards that include all 26 letters of the alphabet
- Tablet computer keyboards using word-processing software
- Alternate keyboard (e.g., onscreen or switch-enabled keyboard)
- Alternate pencils, including alphabet flip charts
- Eye-gaze displays of letters
- Letter-by-letter dictation of any sort
- Word-prediction software*

SUPPORTS NOT ALLOWED FOR WRITING TESTLETS

The following supports are **not allowed** for writing testlets:

- Speech-to-text software**
- Whole-word or sentence dictation; to test the full criteria of writing Essential Elements, students are not allowed to dictate whole words or sentences.
- Selection of pictures or words from a word bank

Word prediction and text-to-speech are two very different types of software. Understanding the difference between the two is very important in understanding why DLM allows word prediction but not speech-to-text.

***Word Prediction** (allowed for DLM writing testlets)

- Word prediction is a digital tool. It responds to letter-by-letter input from the user. Specifically, word-prediction software uses the letters a student selects to predict the word the student is trying to type. With each new letter the student selects, the tool refines the words in the list. Most word-prediction tools will use the letters selected by the user and any other words that have been written to refine the guesses.
- The number of words in the list can be adjusted (generally a maximum of nine words) and most commercial word-prediction options restrict words in the list to words that are grammatically possible, given other words that have already been typed. Other features may be available depending on the specific word-predication application being used. For example, some word-prediction tools make guesses based on the phonemes represented by the selected letters, not just the grapheme.
- Word prediction primarily supports spelling accuracy but can also support syntax (i.e., grammar) while requiring the student to compose text by using letter-by-letter spelling. Word prediction can improve writing fluency for some students with physical disabilities, but it does so without turning the composition task into an oral language task.

****Speech-to-Text** (not allowed for DLM writing testlets)

- Speech-to-text is a digital tool. It responds to spoken input from the user. Like a human scribe, speech-to-text software translates spoken input (letters, words, sentences, and extended text) into text. Speech-to-text software allows students to generate text without letter-by-letter spelling. It supports turning oral language into a written text without requiring any knowledge of the concept of words or the ability to spell.

The distinction between the two supports is important in the DLM alternate assessments in ELA, especially in the context of the writing testlets. In the DLM alternate assessments in ELA, writing is defined as, “the process of constructing texts in traditional print or braille that communicate thoughts, feelings, and understandings for diverse purposes and audiences”

(go to the video for Instructionally Embedded model states: [Dynamic Learning Maps Writing Testlets Overview](#)).

The writing testlets in the DLM alternate assessments in ELA require students to apply a coordinated set of abilities to communicate thoughts, ideas, or information by attending to the mechanics of transcription and organization.¹ In most testlets, students select and communicate about a topic using the modes of communication they use across contexts. In each testlet, students are required to use a pencil, keyboard, or letters of the alphabet accessed in some other way to compose text with letter-by-letter spelling. Word prediction supports but does not eliminate the need to use individual letters to spell words. Speech-to-text can eliminate this need by allowing students to dictate whole words and sentences.

PICTURES, SYMBOLS, OR USE OF A WORD BANK

Pictures, symbols, or words from a word bank are not allowed and may not be substituted for words in a sentence. This practice is forbidden because the meaning that an individual assigns to a picture or symbol depends upon the individual's motivation; neurological and developmental status; sensory abilities; cognitive, communication, and language skills; and world experience (Mineo Mollica, 2003). Furthermore, the ability to learn the meaning of pictures or symbols is directly related to an individual's understanding of the word associated with the picture or symbol.

In other words, individuals who understand the meaning of the spoken word learn the associated picture or symbol rather easily, while individuals who do not understand the spoken word need more time to learn the meaning of the picture or symbol (Ronski & Sevcik, 1996, 2005). Because students who participate in the DLM alternate assessment have universally impaired cognitive and language skills, it is not possible to ensure that each student's understanding of pictures and symbols introduced in the assessment will match the intended meaning.

WRITING TOPIC

For both levels of writing testlets, the test administrator and the student participate in an engagement activity related to choosing a topic on which to write. The testlet does not include preselected topics for writing assessments.

- In emergent writing testlets at the Initial Precursor and Distal Precursor linkage levels, the students often choose from a list of topics that they have been exposed to during instruction.
- In conventional writing testlets, students also write about familiar topics. If able, they independently select a subject on which to write. The topic is to be an informational one that is relevant to instruction and familiar to the student.
- The student can use the same topic in both the fall window and the spring window.

TEST ADMINISTRATOR TASKS IN WRITING TESTLETS

The test administrator has two types of tasks in writing testlets:

- 1) The test administrator evaluates a process used in writing. Testlet items are presented to the test administrator while the student works through the writing testlet.
- 2) The test administrator evaluates the student's final writing product.

For the first type of task, test administrators will perform the following steps (Figure 32):

- 1) Give the student a verbal prompt from the onscreen Educator Directions. As apparent in the following image, the verbal prompt may be, "SAY: You are going to write about a person, place, or object today. What would you like to write about?"
- 2) The test administrator may present the student with a list of familiar topics that have been used during instruction, or the student may think of a topic without any prompting.
- 3) The testlet screen prompts the test administrator to ask the student to engage in writing tasks.
 - a) An example of a verbal prompt may be, "SAY: Write about [topic] using words that describe [topic]."
 - b) The test administrator says the prompt aloud to the student, inserting the actual topic selected for the writing testlet.
- 4) The test administrator is directed to WAIT and OBSERVE the student's writing process in response to the prompt. Patiently waiting is a **very important** step for the test administrator to do so that the student has enough time to respond.
- 5) The test administrator evaluates the student's behavior according to the description in the response options. The test administrator then chooses the description that best matches the student's writing process.

Educator Directions for a Writing Testlet in Kite Student Portal

Educator Directions:

SAY: "You are going to write about a person, place, or object today. What would you like to write about?"

Give the student time to make a choice about a topic used in shared reading and during instruction. If the student is unable to select a topic, select a topic for the student to write about. When the student is ready to begin, select "NEXT."

EXAMPLE: If the student's behavior could be described by two response options, the test administrator should select the response option that represents the higher of the two options. In the following image, if the student wrote some words related to the topic and some words that were not related to the topic, the test administrator has two response options from which to select: "Wrote at least one word related to the topic," or "Wrote a word or words that were not related to the topic." In this case, the test administrator would select the higher of the two options: "Wrote at least one word related to the topic."

The response options in Figure 33 are as follows:

- Wrote facts, details, or other information related to the topic
- Communicated about facts, details, or other information related to the topic, but did not write
- Wrote at least one word related to the topic
- Wrote a word or words that were not related to the topic
- Wrote letters
- Wrote marks or selected symbols other than letters
- Did not communicate or write about the topic

Response Screen in a Writing Testlet in Kite Student Portal

After the student has finished writing, choose the highest level that describes your evaluation of the final product. Spelling is not evaluated in this item.

- ☐ Wrote facts, details, or other information related to the topic

When a student’s performance does not exactly match any response option, the test administrator selects the option that best matches the student’s performance (Table 18).

Student Performance and Test Administrator Responses During an Assessment

Student’s Performance	Test Administrator’s Response
The student wrote complete sentences about the topic using at least two descriptive words.	The test administrator selects the response, “Wrote facts, details, or other information related to the topic.”
The student wrote incomplete sentences but still conveyed ideas and information about the topic using at least two descriptive words.	The test administrator selects the response, “Wrote facts, details, or other information related to the topic.”

Student's Performance	Test Administrator's Response
The student did not write anything about a topic.	The test administrator selects the response, "Did not communicate or write about the topic." If that response is not available, the test administrator would choose "No response" if available. If neither of these responses is available, the test administrator leaves the item blank.

For the second type of task, found in most conventional writing testlets, the test administrator is required to evaluate the student's final writing product. The evaluation items may be in single-select multiple-choice or multiple choice-multi-select format. The test administrator completes this task only after the student has finished writing. The test administrator will

- look at the writing the student produced
- evaluate the student's writing product
- choose the description that matches the highest level of the student's writing

RETENTION OF THE WRITING PRODUCT

Retention of a student's written product is a policy decision made at the state or local level. The assessment coordinator can provide information about the policy requirements (i.e., how long to store and where to store the student's writing product).

For research and technical documentation, DLM staff may request test administrators to electronically scan and submit their student's final written product. If this request occurs, the test administrators and their assessment coordinators will be informed in advance about how to electronically submit the student's final written product. Writing products should not be mailed using the postal system.

TEACHER-ADMINISTERED MATHEMATICS TESTLETS

Mathematics testlets at the Initial Precursor level are always teacher-administered testlets and will include **No response** as one of the response options. Some testlets at higher linkage levels in mathematics are also teacher-administered when the tested content is over performance-based skills (e.g., measuring, counting). These testlets may also include **No response** as one of the response options.

An example is a procedural node that asks the student to measure volume. Recognizing three-dimensional objects and manipulating them onscreen requires keen perceptual and motor skills, neither of which are essential to the student's cognitive understanding of how to measure volume.

For students who are blind, have visual impairments, or have physical disabilities that impact their ability to take the testlet onscreen, the test administrator should directly administer these types of testlets to make them accessible.

STRUCTURE OF TEACHER-ADMINISTERED MATHEMATICS TESTLETS

All teacher-administered mathematics testlets are similar in their structure. They include instructions to the test administrator called Educator Directions.

- First, the directions tell the test administrator, in a general way, what will happen in the testlet.
- Second, the directions specify any materials that need to be collected.

More information about the materials and recommended substitutions are in the TIP, which the test administrator will need to access before test administration. The teacher-administered math testlets do not have alternate text included, because those testlets do not have images associated with them. Those TIPs have only a TIP cover page.

The last part of the TIP's directions page outlines the needed materials, which items need the materials, and in what order the materials are presented in the item. The test administrator may make substitutions if the substitutions do not change what is being measured in the testlet and if the materials are still grouped as indicated in the testlet directions.

Figure 34 is an example of Educator Directions for an Initial Precursor mathematics testlet.

Educator Directions:

In this testlet you will present the student with familiar objects of different shapes. It is important that the student can identify the objects through his or her preferred means of communication.

Gather 3 familiar objects, such as a ball, a block, and a book. You may substitute other objects as long as they have different shapes and at least one is round.

For the first item, you will use the ball (or other round object) and the block. For the second item, you will use the ball and the book.

Teacher-administered mathematics testlets begin with an engagement activity, which occurs when the test administrator presents the materials used in the testlet and engages the student in exploring the materials. Figure 35 is an example of an engagement activity in a teacher-administered mathematics testlet.

An Engagement Activity in a Teacher-Administered Mathematics Testlet

Educator Directions:



Present the eight napkins to the student in a way that captures the student's attention. For example:

- Draw the student's attention to the presence of the napkins.
- Talk about how napkins are used.

Once the student has attended to the napkins, stack five napkins together and leave three napkins separated. Indicate to the student that the stacked napkins are in a group and the other napkins are separate.

On the next screens, you will ask the student some questions about the napkins.

TEACHER-ADMINISTERED SCIENCE TESTLETS

NOTE: Check your state's webpage to determine if your state tests DLM science.

Teacher-administered science testlets are at the Initial linkage level and are administered similarly to mathematics testlets. For these testlets, objects must be gathered, or picture-response cards must be printed ahead of time. The student works with the test administrator outside of Student Portal, and the test administrator enters the student's responses in Student Portal. Testlets at the Initial linkage level will include the **No response** answer option.

PICTURE-RESPONSE CARDS FOR TEACHER-ADMINISTERED SCIENCE TESTLETS


Initial linkage level science testlets are structured as a series of statements that the teacher reads to the student, and the TIP usually includes objects that must be gathered or picture-response cards that must be printed prior to test administration. Best practice is to print picture-response cards in color. Administration of the testlet will not be possible without the picture-response cards or the objects.

STRUCTURE OF TEACHER-ADMINISTERED SCIENCE TESTLETS

All teacher-administered science testlets are similar in structure. They include instructions to the test administrator called Educator Directions. Figure 36 is an example of Educator Directions for an Initial linkage level science testlet.

Educator Directions for an Initial Linkage Level Science Testlet in Kite Student Portal




The directions tell the test administrator, in a general way, what will happen in the testlet and will specify any materials that must be collected. The TIP lists these materials and may also list recommended substitutions. The test administrator may substitute materials if the substitutions do not change what the testlet measures. The last part of the directions page outlines the needed materials, which items need the materials, and in what order the item presents the materials.

Additionally, teacher-administered science testlets contain an engagement activity in which the test administrator presents the picture-response cards or objects and then engages the student in exploring the materials. Figure 37 is an example of an engagement activity in a teacher-administered science testlet.

PRACTICES ALLOWED

Items in the DLM testlets are designed to assess student knowledge, skills, and understanding related to the Essential Elements. To meet this goal, test administrators will need to use their best judgment and be flexible while administering the assessment, including providing supports beyond PNP Profile options and the allowed practices listed. The following practices are allowed in both computer-delivered and teacher-administered testlets, unless exceptions are noted on the TIP.

BREAKS

Students may take breaks during or between testlets. Test administrators need to use their best judgment about the use of breaks. Although the goal is to complete a testlet in a single session, breaks may be needed when the student is fatigued, disengaged, or having behavioral problems that may interfere with the student being able to demonstrate what they know and can do.

INDIVIDUALIZED STUDENT RESPONSE MODE

The items in the teacher-administered testlets do not limit response modes to certain types of expressive communication; all response modes are allowed. Test administrators may need to represent response options outside of the system to maximize the student's ability to respond. For example, for a student who uses eye-gaze technology to communicate, the test administrators may represent the response options in an alternate format or layout to

ensure the student can indicate a clear response. The test administrator must be familiar with the student's typical modes of expressive communication, because any mode for communicating a response is acceptable.

SPECIAL EQUIPMENT DURING TESTING

Some students may need special equipment to access the assessment material, such as a slant board for positioning or hook-and-loop objects on a communication board. Test administrators should use the equipment to maximize the student's ability to provide a clear response.

NAVIGATION ACROSS SCREENS

For any student who has difficulty interacting directly with the computer because of a lack of experience, limited fine motor skills, or use of interactive devices, the test administrator may help the student navigate across screens.

ENTERING RESPONSES FOR A STUDENT

If a student is unable to enter a response into the computer but can indicate a response in some other fashion, such as through eye gaze, the test administrator may enter the response into the testlet on behalf of the student. Again, the student's method for responding to items should be consistent with the student's usual means of expressing choices.

ENLARGEMENT OF THE ASSESSMENT

Some students have severe visual impairments and need larger presentations of the content than is provided by the 5× magnification setting in the Personal Needs and Preferences (PNP) Profile. Also, some students may not have the fine motor skills needed to select a response option on the screen of a typical, average-sized computer device. In these situations, the test administrator may use any device that enables the student to see the assessment or to use their gross motor skills to indicate their response options, such as an interactive whiteboard, a magnification device, or the projection of the assessment to make it larger.

ALTERNATE REPRESENTATIONS OF RESPONSE OPTIONS

Pictures or objects may **not** be used to represent text-based response options. For example, if response options are words (i.e., text), then the responses may not be represented by pictures or objects. However, if the onscreen response option is a picture of a circle, a square, and a triangle, the educator may represent the response options using shapes on a communication board or objects that are the shapes.

Additionally, representing the response options in an alternate format is allowed if the representation does not favor one response over another. For instance, the correct response cannot always be closest to the student or in the same position each time.

GRAPHIC ORGANIZERS

If the student is accustomed to using specific graphic organizers, manipulatives, or other supports during instruction, the use of those supports is allowable during the DLM alternate assessment.

BLANK PAPER

If the student requires blank lined or unlined paper, it may be provided to the student. However, once the student has written anything on it, the paper then becomes a secure assessment document. At the conclusion of the assessment session, the paper must be securely destroyed along with the TIP.

USE OF REINFORCEMENT

Natural or direct reinforcement may be used to promote appropriate participation in the administration of the assessment. Tangible reinforcement (e.g., stickers, tokens) or social reinforcement (e.g., praise, high fives) may be used to promote appropriate on-task behavior. These types of reinforcement should be used only for appropriate and continued participation, but they must not be used to sway or lead the student to the correct response.

GENERIC DEFINITIONS

If the student does not understand the meaning of a word used in the assessment, the test administrator may define the term generically and allow the student to apply that definition to the item in which the term was used. Exceptions to this general rule are noted on the TIP for specific testlets.

PRACTICES NOT ALLOWED

Although many supports and practices are allowable for computer-delivered and teacher-administered testlets, some practices are not allowed. These practices include the following:

- Repeating the item activity after a student has responded or in any other way prompting the student to choose a different response
- Using physical prompts or hand-over-hand guidance to direct the student to the correct response
- Removing response options or giving hints to the student

- Rearranging objects to prompt the correct response (e.g., putting the correct response closer to the student)

For questions about whether a particular support is allowable, test administrators must contact their assessment coordinator. If supports outside of those listed are provided for a student, some states require a description of those supports be provided using a state reporting system. To avoid invalidating the student's assessment, follow state-specific guidelines and get approval from the assessment coordinator before using other supports.

OTHER ACCESSIBILITY SUPPORTS

Accessibility supports that are appropriate for use during teacher-administered and computer-delivered testlets are described throughout the ACCESSIBILITY MANUAL. The following describes some supports in more detail.

LANGUAGE TRANSLATION

Because disability-related cognitive and communication challenges for students with the most significant cognitive disabilities are unique, and because English learners speak a wide variety of languages, the DLM alternate assessment does not provide translated forms of testlets. Instead, the DLM alternate assessment supplies test administrators with instructions regarding allowable supports based on each student's unique combination of language-related and disability-related needs, and on the specific construct measured by a particular testlet.

The test administrator will receive a TIP for each testlet. The TIP includes information about exceptions to the general rule of allowable translations. For example, when an item assesses knowledge of vocabulary, the TIP will include a note when the test administrator may not define or translate terms for the student on that testlet.

NOTE: Some states do not allow language translation. Check with your assessment coordinator about language translation.

Unless exceptions are noted in the TIP, test administrators may do the following:

- Translate the text
- Simplify testlet instructions
- Translate words on demand
- Provide synonyms or definitions
- Accept responses in either English or the student's native language

NOTE: Student Portal does not offer a digital dictionary. Students may use their version of a dictionary if needed, such as word lists and communication symbols. This dictionary should be familiar to the student and should have been used during instruction.

SIGN INTERPRETATION

Students who are Deaf or hard of hearing and who participate in the DLM alternate assessment may require additional supports beyond those available via the PNP Profile. Support needs may be different for computer-delivered testlets than for teacher-administered testlets.

Directions in the teacher-administered testlets describe how to organize and present the content to the student. Scripted directions tell the test administrator what to say or sign. For English learners, the test administrator will need to determine if the student can understand a direct translation of the script or if the student will need an interpretation of the directions. If interpretation is needed, in most situations, the TIP may provide the needed information for a test administrator to be prepared for test administration. However, in some situations, other advance planning may be necessary.

SIGN INTERPRETATION FOR STUDENTS WHO NEED TRANSLATIONS

When necessary for a student who is Deaf or hard of hearing and needs translation, a test administrator is permitted to sign in to Student Portal before beginning the assessment to plan and prepare for appropriate procedures to use with the student. If the need for interpretation is likely, the test administrator is permitted to review the screens to evaluate the need for interpretation. If administration occurs later, the test administrator should use the **EXIT DOES NOT SAVE** button to leave the testlet. If **EXIT DOES NOT SAVE** is not permitted in your state, special permission may be needed ahead of time. Contact the assessment coordinator to report this need in advance.

For teacher-administered testlets, test administrators may do any of the following:

- Translate the text (American Sign Language, Signed Exact English, or individualized)
- Translate words on demand (e.g., English to American Sign Language)
- Provide synonyms and definitions except when specifically forbidden on the TIP (e.g., when the item assesses knowledge of vocabulary)
- Accept responses in the student's sign language system (American Sign Language, Signed Exact English, or individualized) or through the student's communication device
- Reread the text if the student indicates a need

OTHER PRACTICES ALLOWED

Students who participate in the DLM alternate assessment have access to many accessibility supports. Test administrators may also be flexible with some aspects of testlet delivery. However, testlet delivery must be standardized in certain ways. This section describes general principles for additional allowable practices when the accessibility supports included in the PNP Profile do not meet the student's needs. When possible, the additional supports must be consistent with the student's current needs as documented in the IEP.

When making decisions about additional supports for computer-delivered testlets, test administrators must follow IEP team decisions and these two general principles:

- **Provide flexibility in student access and response mode.** For example, standard administration procedures define typical arrangements for the test administrator, the student, and the computer for different types of testlets. However, the test administrator may need to adapt the physical arrangement based on a student's physical needs and use of special equipment. Another example of this flexibility is the substitution of materials as needed for the testlet.
- **Maintain consistency in the student's interaction with the concept being measured.** All students do not have to interact with identical materials or respond using the same response mode, but all students do complete the same cognitive or linguistic task. Therefore, test administrators cannot rephrase questions or rearrange items. Simplified instructions, definitions, and flexible response modes are allowable practices for all students, except when specifically excluded by the TIP. TIPs for testlets at the lower linkage levels provide information for material substitutions to help the test administrator maintain this consistency. For a computer-delivered testlet, most of what the student needs is displayed on the screen in the testlet.
- To determine whether a practice is allowed, go to Practices Allowed and Practices Not Allowed beginning on page 105 of this manual. Also, in the ACCESSIBILITY MANUAL, go to Supports: Allowed and Not Allowed.

TESTLETS FOR STUDENTS WHO ARE BLIND OR HAVE VISUAL IMPAIRMENTS

BRILLE FORM TYPES

DLM alternate assessments are in uncontracted braille. Braille forms are only available for some ELA, mathematics, and science Essential Elements and only at the upper linkage levels. Table 19 on page 112 shows the windows, subjects, and linkage levels where braille forms may be available. Each state assessment administrator decides whether to offer one,

two, or all three braille codes in the state. In the student's PNP Profile, the test administrator selects the appropriate braille form for the student:

- EBAE
- UEB with Nemeth
- UEB Math/Science

For more information about braille, go to the [Braille Authority of North America \(BANA\)](#) website. The BANA position statement, [Terminology: UEB Math/Science and UEB with Nemeth](#), was adopted in September 2020 and is available in a PDF on their website.

The DLM alternate assessment is designed to assess students' knowledge, skills, and understanding of the Essential Elements, not the student's ability to use braille. Therefore, braille should be selected only if the student is proficient in reading braille and should not be selected for emerging braille readers. The alternate form-visual impairment option may be more suitable for a student with a visual impairment who is not proficient in reading braille.

BRAILLE FORM AVAILABILITY

Braille forms and the Alternate Form-Visual Impairment option are **not** available for all Essential Elements and linkage levels (Table 19). Based on availability for every Essential Element being tested, a student will receive one of three forms of a testlet as shown in the following list:

- A limited number of braille forms are available. Go to Table 19 for the subjects, grades, linkage levels, and window availability.
- A limited number of the alternate form-visual impairment options are available during the fall and the spring windows.
- Standard forms are **always** available for the assessment.

HINT: When braille or the alternate form-visual impairment option is selected in the PNP Profile, other supports may also be selected, such as Spoken Audio, magnification, and human read aloud.

NOTE: Check your state's webpage to determine if your state tests DLM science.

BRaille FORM DELIVERY

The test administrator marks options in the PNP Profile to have the system deliver a braille or alternate form when available. In the PNP Profile, braille is selected under the Language and Braille tab, while alternate form-visual impairment is selected under the Other Supports tab.

When braille has been selected for a student in the PNP Profile, and since a braille form is not available for every Essential Element at every linkage level, the Kite system works through the following process for delivering a testlet.

- First, if a braille form is available for the Essential Element at the linkage level, the braille form of the testlet is delivered.
- Second, if a braille form is not available for the Essential Element at the linkage level, the Kite system will automatically look for an alternate form-visual impairment form of the testlet: a BVI form.*
- Third, if a BVI form is available for the Essential Element at the linkage level, the BVI form of the testlet is delivered.
- Fourth, if a BVI form is not available for the Essential Element at the linkage level, the system will automatically provide a standard form of the testlet.

*The BVI form is described in more detail later in this manual.


When a standard testlet is delivered, the test administrator is responsible for making information accessible to the student who is blind or visually impaired, using permissible, familiar methods that were used during normal classroom instruction with the student. When appropriate, the TIP for the standard form testlet may contain information about adaptations for delivering the testlet. Every TIP that is connected to a testlet with images (either in the text, the engagement activity, the items, or the picture-response cards) has

alternate text for the test administrator to read to the student. The only exception would be if the alternate text for images in the response options would cue the answer to the item.

When the system delivers a braille ready file (BRF) for ELA or mathematics in the fall or spring window, the BRF displays in the Instruction and Assessment Planner with a braille ready file icon (Figure 38). The same icon is used in Test Management for a science BRF in the spring window. (Science does not have braille forms in the fall.)

Option for Braille Ready File in the Instruction and Assessment Planner



The test administrator downloads the braille ready file (BRF) and embosses it. For the steps to retrieve, download, and emboss the BRF, go to the Retrieve Braille Ready File section of the EDUCATOR PORTAL USER GUIDE.

Braille forms are transcribed to be as similar as possible to standard testlets, but embossed testlets may contain minor differences to help students more easily access and navigate the information:

- Page numbers are included on all testlets to help with organization.
- Response options are lettered to help students communicate their responses so that test administrators can input the responses in Student Portal.
- Science texts are double-spaced to help students whose braille-tracking skills are not yet strong.

BRaille TIP

The braille TIP includes only the TIP cover page. All items in an ELA braille testlet are based on the text portion of the story and not the images. Since the images are not part of the braille form that a student would be reading, the alternate text is not needed for a student using a braille form to answer any items. For a mathematics or science braille form testlet, the test administrator can use objects or tactile graphics when administering the testlet.

TACTILE GRAPHICS

Tactile graphics are a means of conveying non-textual information to students who are blind or have visual impairments. Tactile graphics may include tactile representations of pictures, maps, graphs, diagrams, and other images.

Tactile graphics are not included with the braille forms for the DLM alternate assessments. Instead, the instructions typically direct test administrators to use objects (especially objects that are familiar to the student) for concrete representations of content. Additionally, the test administrator may create tactile graphics to represent graphics that appear onscreen in the testlet. Review the TIP for each testlet to learn about allowable objects.

SUBMITTING, SCORING, AND HANDLING EMBOSSED BRAILLE FORMS

Every BRF has an equivalent computer-based version of the testlet in Kite Student Portal. As the student responds to each item on their embossed paper version of the testlet, the test administrator inputs the student's responses into the testlet in Student Portal, then submits the testlet. The system scores the responses in the same way as non-braille forms are scored.

For ELA and mathematics, the test administrator can select the next Essential Element for instruction and assessment in both the fall and spring window. For science, braille forms are not available in the fall window.

In the spring window, braille forms are available for some science Essential Elements at the Target linkage level. The BRF icon will be in the Test Management section of Educator Portal. Science testlets are adaptive, and after the first testlet is submitted, the next one will take about 15 minutes to arrive. If the next delivered testlet is a braille testlet, the BRF file will need to be downloaded and embossed. The time for this process must be considered in the test administration schedule.

After all testlets are submitted, the embossed paper forms must be securely destroyed. Consult the assessment coordinator about the process used in your district for securely handling and destroying embossed braille testlets.

ALTERNATE FORM-VISUAL IMPAIRMENT OPTION

Most standard DLM alternate assessment testlets are accessible for students who have visual impairments or are blind but do not read braille. However, certain skills are difficult to assess online for students who have visual impairments, even with supports such as Spoken Audio. For these specific Essential Elements and linkage levels, the system may assign the alternate form-visual impairment option, which is often called a Blind Visual Impairment (BVI) testlet. These testlets have alternate item structures and engagement activities to make them accessible for students. The BVI option is only available for certain Essential Elements and linkage levels. The test administrator **must** select the alternate form-visual impairment option in the PNP Profile.

When the BVI option is delivered, the testlet will contain the letters **BVI** in the test ticket, the TIP, and the Student Portal testlet name (e.g., SP **BVI** SCI MS.PS1-2 T 10455).

TIPS FOR A TEACHER-ADMINISTERED ALTERNATE FORM-VISUAL IMPAIRMENT OPTION

The TIP may list materials that may require some advanced preparation by the test administrator. Special materials are recommended in the TIP, but other familiar materials may be substituted as described in the TIP.

TIPS FOR A COMPUTER-DELIVERED ALTERNATE FORM-VISUAL IMPAIRMENT OPTION

If a standard form testlet includes images on the screen, the TIP for a BVI option will have alternate text pages with prewritten language that mirrors the description that the computer would read aloud if the student was using Spoken Audio. Alternate text is only included for images, because the onscreen text of the stem (question) and answer options can be read aloud to the student by the test administrator.

The TIP may list materials that require some advanced preparation by the test administrator. It may include instructions for the test administrator on how to use materials to replicate the images on the screen into tactile options for the student. Instructions inform the test administrator when to present certain materials (e.g., prior to or after asking the question).

Substitutions are allowed as directed on the TIP.

ADMINISTRATION OF ALTERNATE FORM-VISUAL IMPAIRMENT OPTION TESTLETS

The general procedures for administering BVI testlets are the same as those described in previous sections. In addition, test administrators may find the following options particularly helpful when administering BVI testlets:

- If the student also has a physical disability that makes manipulating objects difficult, take direction from the student or act on the student's behalf by manipulating materials and selecting the responses indicated by the student.
- Spoken Audio can be selected in the PNP Profile. Spoken Audio will be available 24 hours after it is selected and saved.
- Human read aloud can always be provided by the test administrator, using the alternate text at the end of a TIP that is connected to a testlet with images (either in the text, the engagement activity, the items, or the picture-response cards).
- If any materials are being substituted, change the language in the testlet to match the substituted object. For example, if the testlet uses cakes in fractional pieces and the student has been learning fractions using pizzas, pizzas may be substituted, then also change the word *cake* to *pizza* when reading the text aloud.

To make a change regarding braille or alternate forms during the assessment, consult the Accessibility Manual in the section titled Changing PNP Profile Settings During Testing.

GUIDELINES FOR USING THE INSTRUCTION AND ASSESSMENT PLANNER IN THE SPRING WINDOW

KEY FACTS FOR ELA AND MATHEMATICS

The key facts for the spring window for English language arts (ELA) and mathematics are the same as the fall window (Table 20). Key steps for science in the spring window are found on page 121.

NOTE: If needed, updates can be made to the Personal Needs and Preferences (PNP) Profile before the spring window. However, the First Contact Survey does not need to be completed again.

Specific step-by-step procedures with screenshots for using the Instruction and Assessment Planner are provided in the EDUCATOR PORTAL USER GUIDE. They will not be provided in this manual.

SPRING WINDOW—ELA AND MATHEMATICS

For English language arts (ELA) and mathematics, the process in the spring window is the same as described in the fall window earlier in this manual. One difference is in how linkage levels are recommended in the spring.

SELECT A LINKAGE LEVEL

In the spring window, for ELA and mathematics Essential Elements, the system-recommended linkage level is based on student performance during the fall window **if the Essential Element was assessed during the fall window**. However, if the Essential Element was not assessed during the fall window, the linkage level recommendation is based on the test administrator's responses in the student's First Contact Survey. Again, in the spring window, the test administrator may use the system-recommended linkage level or select another.

The writing Essential Elements are unique. Even though a writing testlet is required in the fall window, the linkage level recommendation for the writing Essential Elements in the spring window is based only on the test administrator's responses in the writing section of the student's First Contact Survey.

INDIVIDUAL STUDENT SCORE REPORTS FOR ELA AND MATHEMATICS

The scoring system for the Dynamic Learning Maps® (DLM®) alternate assessment is different from that of traditional alternate assessments. Students are not given raw scores, percentage-correct scores, or scale scores. Instead, the system combines a student's responses on required operational testlets in the fall and spring windows, using a complex algorithm to determine which linkage levels the student has likely mastered. Summative results are determined from linkage level mastery data. ELA and mathematics summative outcomes are based on the Essential Elements assessed during both the fall and spring windows.

Results for each linkage level are determined by the probability that the student has mastered the skills at that linkage level. The information about each linkage level leads to a summary of the student's mastery of skills in each conceptual area for ELA and mathematics and then for each overall subject. Results are based on all assessed Essential Elements in the blueprint for ELA and mathematics.

The EDUCATOR PORTAL USER GUIDE contains information about retrieving Individual Student Score Reports in the section titled Access Reports and Data Extracts. Scoring and reporting videos are available to help educators interpret score reports. These are located on each

state's webpage under the Resource Category, Scoring and Reporting. One example is an 11-minute video titled [How to Interpret and Use DLM Score Reports](#).

NOTE: Score report outcomes for science are based only on the science Essential Elements assessed during the spring window.

Only certain roles in Educator Portal are allowed access to the reports, which is determined by state policy. Test administrators should contact their district or building test coordinator about reviewing students' Individual Student Score Reports.

SPRING WINDOW—SCIENCE

NOTE: In the spring window, science administrative tasks (e.g., accessing the TIP) are in the Test Management section of Educator Portal.

KEY STEPS FOR SCIENCE

NOTE: Check your state's webpage to determine if your state tests DLM science.



Science in the spring window is required and is administered from the Test Management section of Educator Portal (Table 22). During the spring window, the system determines the order in which the Essential Elements are assessed and the linkage level assignment for each. The test administrator cannot change either one. Step-by-step guidance for using the Test Management section of Educator Portal is found in the EDUCATOR PORTAL USER GUIDE.

RETRIEVE TESTLET INFORMATION PAGE

The test administrator will retrieve the TIP in the Test Management section in Educator Portal. The student takes each science testlet in Student Portal. Once the student finishes the testlet and submits it, the next science testlet becomes available in approximately 15 minutes.

GATHER MATERIALS

For science testlets at the Initial linkage level, before beginning the assessment, print the science picture-response cards or gather any objects described in the TIP. Go to Materials for ELA, Mathematics, and Science on page 50 of this manual for more information.

OTHER REQUIREMENTS

Regardless of the subject or linkage level of the testlet, educators need the following when administering a DLM alternate assessment:

- Assessment device with the most current version of Kite Student Portal app, **not** the browser version of Student Portal
- Student's username and password
- Assistive devices appropriate for the student (if applicable)
- Headphones for use with computer Spoken Audio if other students are in the room
- TIP


NOTE: Although a student's username remains the same from year to year, each year when the student is enrolled in Educator Portal, the student is assigned a brand-new password.

MONITOR TESTING PROGRESS FOR SCIENCE DURING SPRING WINDOW

Testing progress of spring science testlets can be monitored in two places. The first place is in Student Portal on the screen where the testlet is opened. A message will indicate the test progress of the specific science testlet (e.g., Testlet 3 of 9; go to Figure 40).

The second place is on the Test Management screen in Educator Portal, where the Test Progress column has a progress indicator for science testing. Those numbers will match the indicator in Kite Student Portal. In Figure 41, the student is on the third of nine required science testlets for their grade band (e.g., Testlet 3 of 9).

INDIVIDUAL STUDENT SCORE REPORTS FOR SCIENCE

Only linkage level mastery data from the required spring window are used to determine summative results for science. Students are not given raw scores, percentage-correct scores, or scale scores. The system uses a complex algorithm to determine the science linkage levels the student has likely mastered during the spring window. Results are determined from this data.

The EDUCATOR PORTAL USER GUIDE contains information on how to access Individual Student Score Reports in Educator Portal. Go to the section titled Access Reports and Data Extracts.

PREPARE FOR NEXT YEAR

Test administrators and IEP teams should make certain decisions when preparing for the following school year. Two recommended steps are described in Table 23.

HINT: Students access Kite® Student Portal with their own username and password. Staff and educators do not have accounts in Student Portal.

The most current version of Kite Student Portal must be downloaded each year on a student's testing device to take the Dynamic Learning Maps® (DLM®) alternate assessment. Student Portal can be downloaded on a variety of devices. Go to the [Kite Suite](#) page on the DLM website for the 2025–2026 Kite Installation Guides. If Kite Student Portal is used in the browser instead of the downloaded app, operational testlets for the student will not be available.

INTERNET CONNECTIVITY

An internet connection is required to deliver assessments. Your assessment coordinator or technology personnel can help with internet connectivity questions or issues.

KITE STUDENT PORTAL PROCEDURES

NOTE: A testlet **must** begin and end on the **same** testing device. Do not attempt to launch a single testlet on multiple devices. This means a student should not start a testlet on one device and then attempt to launch the same testlet on another device. If the testlet cannot be finished on one device, use **EXIT DOES NOT SAVE** to discontinue the testlet (no answers will be saved). Begin the testlet again on a different device.

Check with your assessment coordinator before testing to find out if the use of **EXIT DOES NOT SAVE** is permitted in your state.

ACCESS PRACTICE ACTIVITIES AND RELEASED TESTLETS

HINT: The most current version of Student Portal must be installed before accessing practice activities or released testlets. Download instructions for each type of device are available on the [Kite Suite](#) webpage on the DLM website.





- 2) Select a subject (**English Language Arts, Mathematics, or Science**). Several pages of released testlets at various linkage levels will be available.
- 3) Complete the testlet or select **EXIT DOES NOT SAVE** to return to the welcome screen.
- 4) Try a different released testlet.
- 5) Sign out and sign back in with a different username and password to try a different student PNP Profile.

STUDENT ACCOUNTS FOR PRACTICE ACTIVITIES AND RELEASED TESTLETS

Practice activities and released testlets are available using several student demo accounts. Each testlet is assigned particular PNP Profile settings based on the username and password being used. The supports, as described in the ACCESSIBILITY MANUAL, are summarized in Table 24.

BEGIN OPERATIONAL ASSESSMENT

To begin the operational assessment, the assessment window must be open, and the student's credentials (username and password) must be used to sign in to Student Portal. The student's credentials will be the same for all DLM alternate assessments, including all testlets administered during the fall and spring windows and all field test testlets.

STUDENT CREDENTIALS FOR STUDENT PORTAL

NOTE: In the following screenshots, the procedures being demonstrated are with fictitious student, Polly Atwood.

A student’s username remains the same from year to year. However, each year when the student is enrolled in Educator Portal, the student is assigned a brand-new password.



During the spring window, administrative tasks for science testlets will be in the Test Management section of Educator Portal. The student's username and password are also available in that section. Select the Test Ticket in the column beside where the TIP is accessed.







NOTE: Repeatedly pressing the back button will take the user back to the Welcome screen but will not close out the testlet. The testlet will remain in an open status until midnight that night unless the user opens the testlet again and uses **EXIT DOES NOT SAVE** or submits the testlet.

SPOKEN AUDIO

When Spoken Audio is enabled in a student's PNP Profile, a **READ** icon will appear at the bottom of the screen. Students may select the **READ** icon to start the Spoken Audio (Figure 44).

As soon as the **READ** icon is selected, a diagonal red line appears across the icon in the testlet, and the word **READ** changes to **PAUSE** (Figure 45).

Spoken Audio will continue reading until the selection is finished or unless the student selects the icon to stop the reading.

If the student selects **PAUSE**, the Spoken Audio stops. The button changes back to **READ**, and the icon becomes uncrossed again. To resume the synthetic voice reading, the student selects **READ** and the Spoken Audio resumes.


Additionally, while the synthetic voice is reading, the sentence or response option on the screen is highlighted in yellow. The screen highlights one sentence or one response option at a time. If the student wants to hear the sentence or response option again, or have the highlighting displayed, the student may select **READ** repeatedly to reactivate Spoken Audio as many times as needed. Once the student is ready to move on, the student selects the **NEXT** button to move to the next screen.

NOTE: If the test administrator selected Overlay Color in yellow in the PNP Profile, the yellow highlighting of Spoken Audio will not be visible.

TAKE A BREAK DURING ASSESSMENT

DLM testlets are not timed, and breaks are not limited during assessment. A student may take a break during an assessment in the following ways:

- 1) **Take a short break (up to 90 minutes).** After 88 minutes and 30 seconds of inactivity in the testlet, the system provides a message with two options: **EXTEND SESSION** or **LOGOUT**. If neither option is selected, after 90 seconds expire, Student Portal will automatically close the session and does not save any responses.




- 2) **Take a break between testlets.** After selecting **END** at the conclusion of a testlet, log out of Student Portal. Log back in when the student is ready to take the next testlet.
- 3) **Stop in the middle of a testlet** using the **EXIT DOES NOT SAVE** button. Student responses will not be saved, and the testlet status reverts to unused. The button

appears on every testlet screen.



The user receives a confirmation message when choosing **EXIT DOES NOT SAVE**.



- a) If **YES** is selected, the testlet will close without saving the student's work. The testlet will be reset, and when the student returns to the testlet, the testlet will start at the beginning.
- b) If **NO** is selected, the student can continue with the testlet.

NOTE: Not all states allow the use of **EXIT DOES NOT SAVE**. Check with the assessment coordinator about using this option before beginning a testing session with a student.

COMPLETE A TESTLET

A review screen appears at the end of a testlet. Figure 46 is an example of the Grade 5 ELA testlet at the Proximal Precursor linkage level where the student did not respond to two of the items. The screen provides an opportunity for the student to go back to those items again unless they were purposefully left unanswered.

Term	Description
alternate text	<p>Alternate text is a standardized description of testlet graphics and images (either in the text, the engagement activity, the items, or the science picture-response cards). Alternate text is ONLY needed when administering the testlet to a student who receives the human read aloud support and/or requires verbal descriptions of images in addition to the text. Alternate text is provided on the Testlet Information Pages (TIPs), which must be accessed prior to test administration. After reading the text on the screen, the alternate text descriptions must be read exactly as they appear on the TIP.</p> <p>The only exception when alternate text is not provided in the TIP is when the alternate text provides a cue to the answer (e.g., if a student is asked to identify which shape is a triangle). In that example, the TIP would not include alternate text that named the shapes in the response options. Instead, the alternate text page would instruct, “Do not describe.” The test administrator could then use shapes or textile graphics.</p>
card	<p>A cell on the Student View Page in the Instruction and Assessment Planner for each Essential Element and linkage level. Information about the specific Essential Element and the specific linkage level can be accessed when the user selects the card.</p>
claim	<p>ELA and mathematics: A broad statement about what the DLM program expects students to learn and to be able to demonstrate in English language arts and mathematics. Each claim is subdivided into two or more conceptual areas.</p>

Term	Description
conceptual area	ELA and mathematics: A region within the DLM learning map containing nodes associated with related Essential Elements, representing concepts and skills that support learning the Essential Elements in English language arts and mathematics. Conceptual areas are composed of clusters of connected concepts and skills and serve as models of how students may acquire and organize their content knowledge. Conceptual areas are considered subparts of the overall claims.
connection	ELA and mathematics: The relationship between two nodes (skills) in the DLM maps. Connections are illustrated with arrows in the maps.
core idea	Science: The key organizing principles in science that are taught and learned over multiple grades at increasing levels of depth and sophistication. For science, within each domain, three or four core ideas have been selected to use for instruction and assessment. Each of the core ideas is narrowed further into topics.
display enhancements	Options that change the testlet appearance on the student's device screen, including magnification, overlay color, invert color choice, and contrast color.
domain	Science: The major science content areas are called domains. The domains that are assessed across all grade bands are physical science, life science, and Earth and space science.
Educator Portal	Educator Portal is a secure administrative application where educators manage student data and retrieve reports and extracts. Users can access Educator Portal using any supported browser via https://educator.kiteaai.org/ . For information on working within Educator Portal, access the DATA MANAGEMENT MANUAL and the EDUCATOR PORTAL USER GUIDE on the DLM website.

Term	Description
engagement activity	ELA, mathematics, and science: An activity at the beginning of a testlet that describes a scenario, taps prior knowledge or experience, or introduces the concept to be addressed. In English language arts (ELA) reading testlets, the first reading of the text often serves as the engagement activity. In mathematics and science, the engagement activity provides context for the items. A few science testlets at the upper linkage levels may include a short video without audio as the engagement activity.
Essential Elements	Essential Elements are the content standards used for the DLM alternate assessments. Essential Elements build a bridge from the grade-level standards to academic expectations for students with the most significant cognitive disabilities. Essential Elements are at a reduced depth, breadth, and level of complexity. They are specific statements of knowledge and skills linked to the grade-level expectations identified in K–12 grade-level standards for English language arts and mathematics. Essential Elements in science are linked to the National Research Council’s Framework for K–12.
Field Test Testlets	Field testing is an essential stage in test development. Field-test testlets are administered in the DLM assessments to conduct a preliminary evaluation of item quality for Essential Elements assessed at each grade level for ELA, mathematics, and science. In addition to evaluating item quality, field testing is also conducted to deepen operational pools so that multiple testlets are available in each window, including making more content available at EEs and linkage levels that educators administer to students the most.

Term	Description
First Contact Survey	<p>A survey completed by the test administrator for each student. The survey is used to collect background information about students who are eligible for DLM alternate assessments. The survey goes beyond basic demographic information and includes questions on communication, assistive technology devices, motor and sensory impairments, and academic performance.</p> <p>In the fall window, data gathered from the survey's core questions together with data gathered from the questions in ELA, mathematics, and science are used to recommend the linkage level for each Essential Element in each subject.</p> <p>The recommended linkage levels in the spring window for ELA and mathematics are based on performance on the Essential Elements that were tested in the fall window. If the test administrator selects an Essential Element that was not tested in the fall window, then the linkage level recommendations will be based on the First Contact Survey.</p> <p>For science in the spring window, data gathered from the survey's core questions together with data gathered from the science questions are used to assign the linkage level for the first Essential Element. After the first tested Essential Element, the linkage level assignment of subsequent testlets is adaptive.</p> <p>For the writing testlet in each window, data gathered from the core questions together with data gathered from the writing questions are used to recommend the linkage level for the writing testlet.</p>

Term	Description
Instruction and Assessment Planner	<p>A section in Educator Portal where test administrators perform assessment functions for a student during both the required fall and spring windows for ELA and mathematics. Functions include selecting an Essential Element and linkage level for instruction and subsequent testing. Most data about the student can be accessed from the Instruction and Assessment Planner, including the results of an Essential Element at the tested linkage level and an indication of when the blueprint requirements are met for each subject tested. The combined scores from each window are summarized in the end-of-year Individual Student Score Reports.</p> <hr/> <p>NOTE: Testing science is optional in the fall window, and score results from the testlets do not impact end-of-year Individual Student Score Reports. Science blueprints do not have to be met in the optional fall window.</p> <hr/>
instructionally embedded assessment	<p>For ELA and mathematics: A required assessment that is closely integrated with instruction throughout the fall and spring windows. Mastery results are indicated for each Essential Element at a linkage level that was tested, except the writing Essential Elements, which are not provided until the end-of-year individual student score reports are published. Instruction for the student can be adjusted before another testlet is administered.</p> <p>For science: An optional assessment that is closely integrated with instruction throughout the fall window only. Mastery results are indicated for each Essential Element at a linkage level that was tested. Instruction for the student can be adjusted before another testlet is administered.</p>

Term	Description
Kite® Student Portal	<p>Kite Student Portal is the customized, secure interface that test administrators use to deliver the assessment to students. All students taking the DLM alternate assessment will have unique accounts in Kite Student Portal. Educators and staff do not have accounts in Student Portal.</p> <p>The most current version of Student Portal must be used and can be found on the Kite Suite webpage on the DLM website. Once launched, Student Portal prevents students from accessing unauthorized webpages or applications during testing.</p> <p>In addition to operational testing in Student Portal, practice activities and released testlets can be administered using Student Portal.</p> <p>A browser version of Student Portal cannot be used to deliver operational testlets.</p>
linkage level	<p>An incremental level of cognitive complexity toward the learning target where an assessment was developed for the Essential Element. Linkage levels for an Essential Element are always related directly to grade-level content standards but at a reduced depth, breadth, and level of complexity.</p> <p>ELA and mathematics each have five linkage levels: Initial Precursor, Distal Precursor, Proximal Precursor, Target, and Successor. These linkage levels are a small section of the DLM learning map containing one or more nodes that represent critical concepts or skills needed to learn the Essential Element.</p> <p>Science has three linkage levels: Initial, Precursor, and Target.</p>
materials	<p>Any objects, manipulatives, and tools used during an assessment. Materials collection lists are specific to each window for each subject. The lists are found on each state's DLM website under Educator Resources.</p>

Term	Description
node	ELA and mathematics: A representation in the DLM learning map of an individual skill or conceptual understanding identified in the research in ELA and mathematics.
Personal Learning Profile	A collective term used to describe a student’s personal needs and preferences settings entered in the Personal Needs and Preferences (PNP) Profile in addition to information about the student entered in the First Contact Survey in Educator Portal.
Personal Needs and Preferences (PNP) Profile	<p>A section in Educator Portal where the test administrator selects settings to meet a student’s personal accessibility needs and preferences for testing in Student Portal.</p> <p>The PNP Profile includes information about display enhancements, language and braille, and audio and environmental supports. Some settings selected in the PNP Profile are programmed in Student Portal (e.g., magnification). Other selections are provided by the test administrator outside Student Portal (e.g., calculator).</p>
plan	<p>ELA and mathematics: A plan is an administrative function in the Instruction and Assessment Planner section of Educator Portal during the required fall and spring windows. The test administrator creates plans by selecting Essential Elements and linkage levels and assigning testlets.</p> <p>Science: A plan is an administrative function in the Instruction and Assessment Planner section of Educator Portal during only the optional fall window. The test administrator creates plans by selecting Essential Elements, linkage levels, and assigning testlets.</p>
released testlets	A released testlet is a publicly available sample DLM assessment. Released testlets may be used by students and teachers as examples or opportunities for practice. Released testlets are developed using the same standards and methods used to develop testlets that are used in DLM operational assessments. New released testlets are added periodically.

stem	<p>The beginning part of the item (question) that presents a problem to solve or a question to which a student responds. The stem may also include other relevant information in the item. A multiple-choice item is a common example in the DLM alternate assessment, consisting of a stem and a set of response options from which a student chooses.</p>
Student Activity Table	<p>The first screen in the Instruction and Assessment Planner in Educator Portal. The Student Activity Table provides an at-a-glance overview for all students rostered to the test administrator in the subjects in which the students are being tested during either the fall or spring window.</p> <p>The data in the Student Activity Table populates based on the test administrator's actions taken on the Student View Page for each student (e.g., how many testlets were administered and the number of blueprint requirements the student has met in ELA and mathematics).</p> <p>The table also includes three icons providing easy access to the First Contact survey, PNP Profile, and the student's credentials (username and password for Student Portal).</p>

Term	Description
Student View Page	<p>A page in the Instruction and Assessment Planner in Educator Portal that displays details for one student at a time, for one subject at a time, for each Essential Element and linkage level. During both the required fall and spring windows for ELA and mathematics, the test administrator uses the Student View Page for several actions for each student (e.g., creating a plan). The system will display information about the student's testing progress, including whether the student achieved mastery of an Essential Element at the linkage level tested. Also, the Student View Page indicates whether blueprint requirements have been met for each individual claim in ELA and mathematics.</p> <p>Testing science in the fall window is optional, and blueprint coverage is not required. Therefore, the blueprint requirements for science will not display on the Student View Page.</p>
tactile graphic	<p>Tactile graphics are a means of conveying non-textual information to students who are blind or have visual impairments. Tactile graphics may include tactile representation of pictures, maps, graphs, diagrams, and other images. The DLM alternate assessment does not provide tactile graphics with the testlets.</p>
technology-enhanced Items	<p>Computer-delivered test items that require a specialized interaction, such as matching and sorting. A technology-enhanced item is any item that is not answered using direct selection, such as multiple choice. This item type is only used for a few items at upper linkage levels in ELA and mathematics.</p>

testlet	A short assessment that begins with an engagement activity followed by items. Most testlets have an average of five items. Together the items increase the instructional relevance of the assessment and provide a better estimate of a student’s knowledge, skills, and understandings than can be achieved by a single assessment item. Each testlet assesses only one Essential Element except for the writing testlet, which assesses all writing Essential Elements together in one testlet. Testlets are either teacher-administered or computer-delivered.
Testlet Information Page (TIP)	<p>A PDF that is unique to each testlet and provides specific information to guide the test administrator in delivering the assessment.</p> <p>The Testlet Information Page (TIP) for most testlets at the Initial and Distal Precursor linkage levels in ELA and mathematics lists the materials needed or describes the attributes of the materials needed specific to a testlet.</p> <p>The TIP at the Initial linkage level for science may list objects that must be gathered or picture-response cards that must be printed before testing. Best practice is to print them in color.</p> <p>Computer-delivered testlets usually require fewer materials than the teacher-administered testlets.</p>


APPENDIX B: DOWNLOADING OR PRINTING DLM FAMILIAR TEXTS


